## 1. General description

The 74LVC2G16 is a dual buffer with Schmitt-trigger inputs. Inputs can be driven from either 3.3 V or 5 V devices. This feature allows the use of these devices as translators in mixed 3.3 V and 5 V environments. This device is fully specified for partial power down applications using  $I_{OFF}$ . The  $I_{OFF}$  circuitry disables the output, preventing the potentially damaging backflow current through the device when it is powered down.




Fig. 1. Logic symbol




Fig. 2. IEC logic symbol




Fig. 3. Logic diagram (one gate)




Fig. 4. Pin configuration SOT363-2 (TSSOP6)




Fig. 5. Pin configuration SOT886 (XSON6)

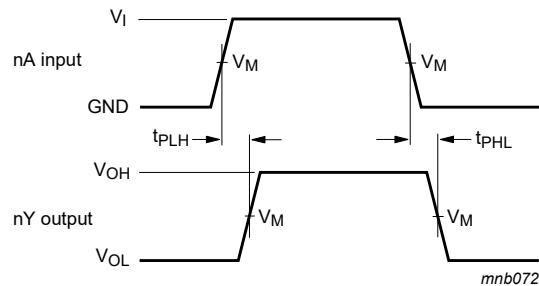

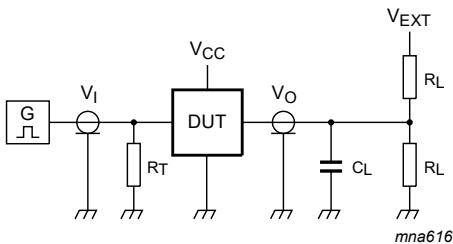

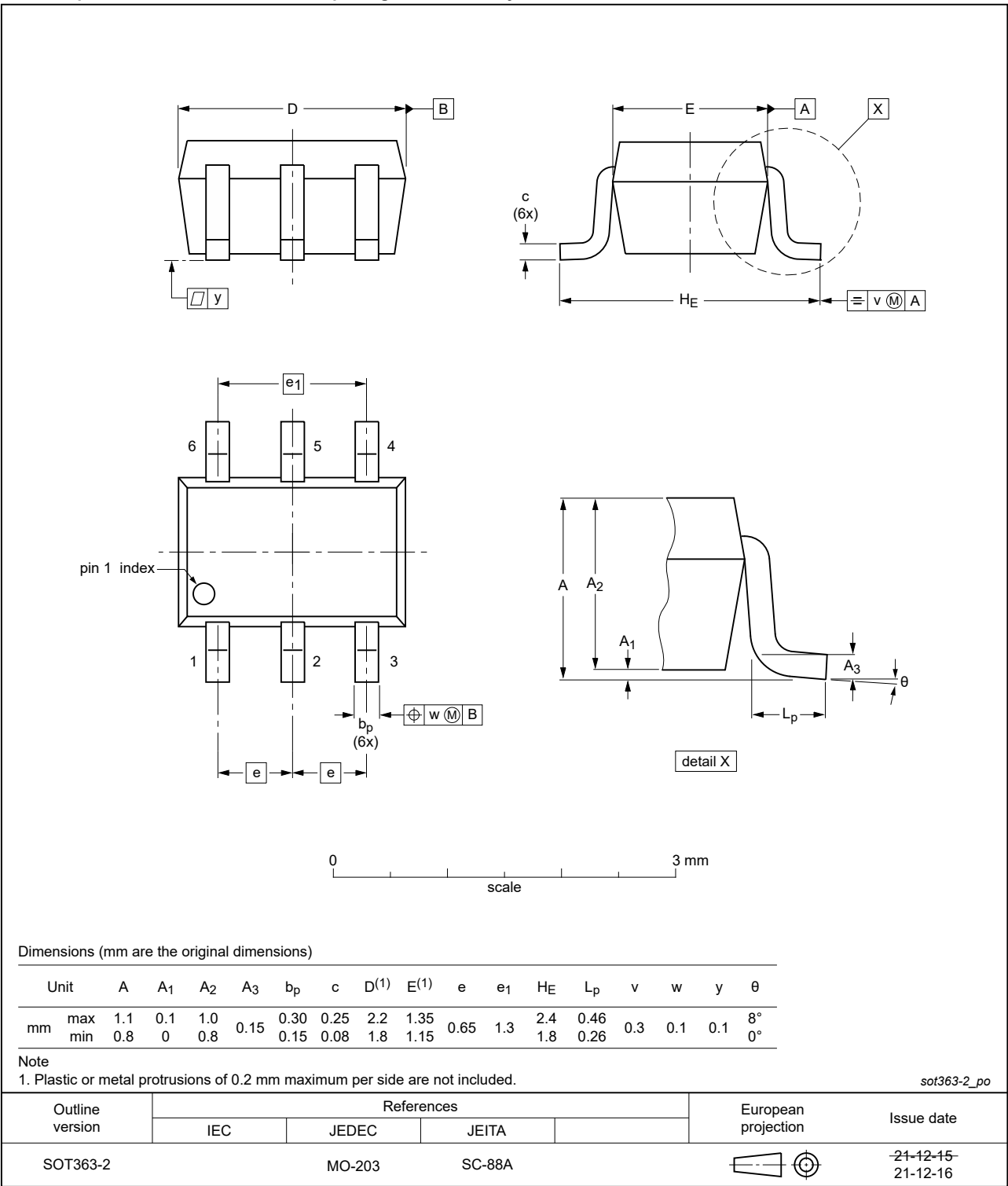


Fig. 8. Package outline SOT363-2 (TSSOP6)

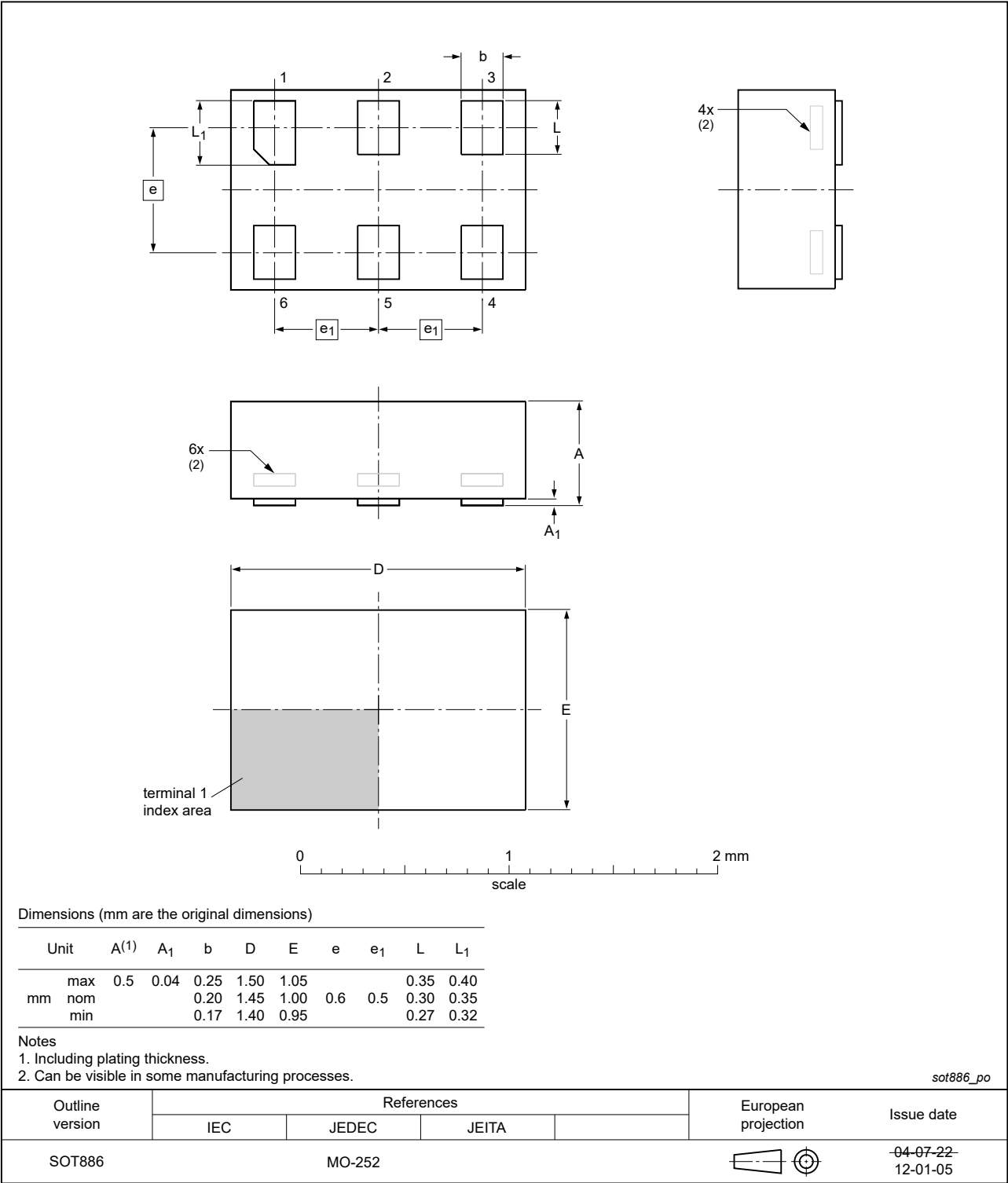


Fig. 9. Package outline SOT886 (XSON6)
