Typical Insertion Loss:



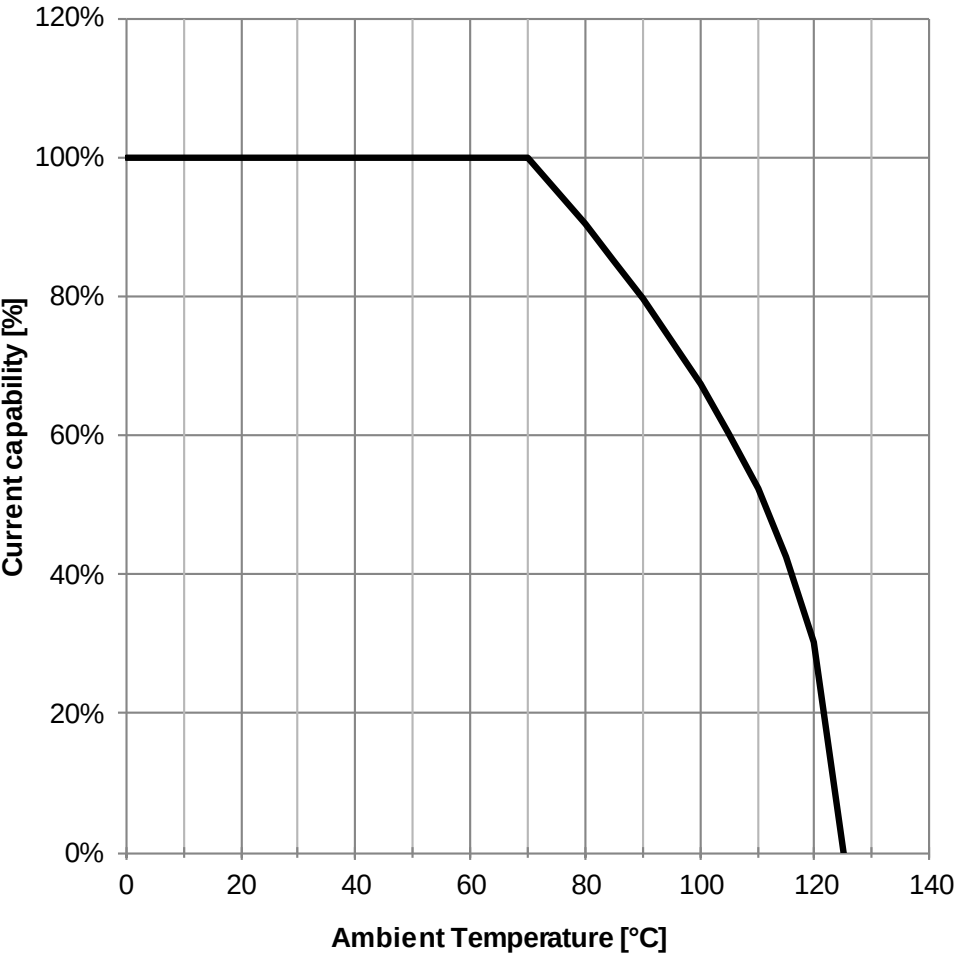
Typical Impedance Characteristics:

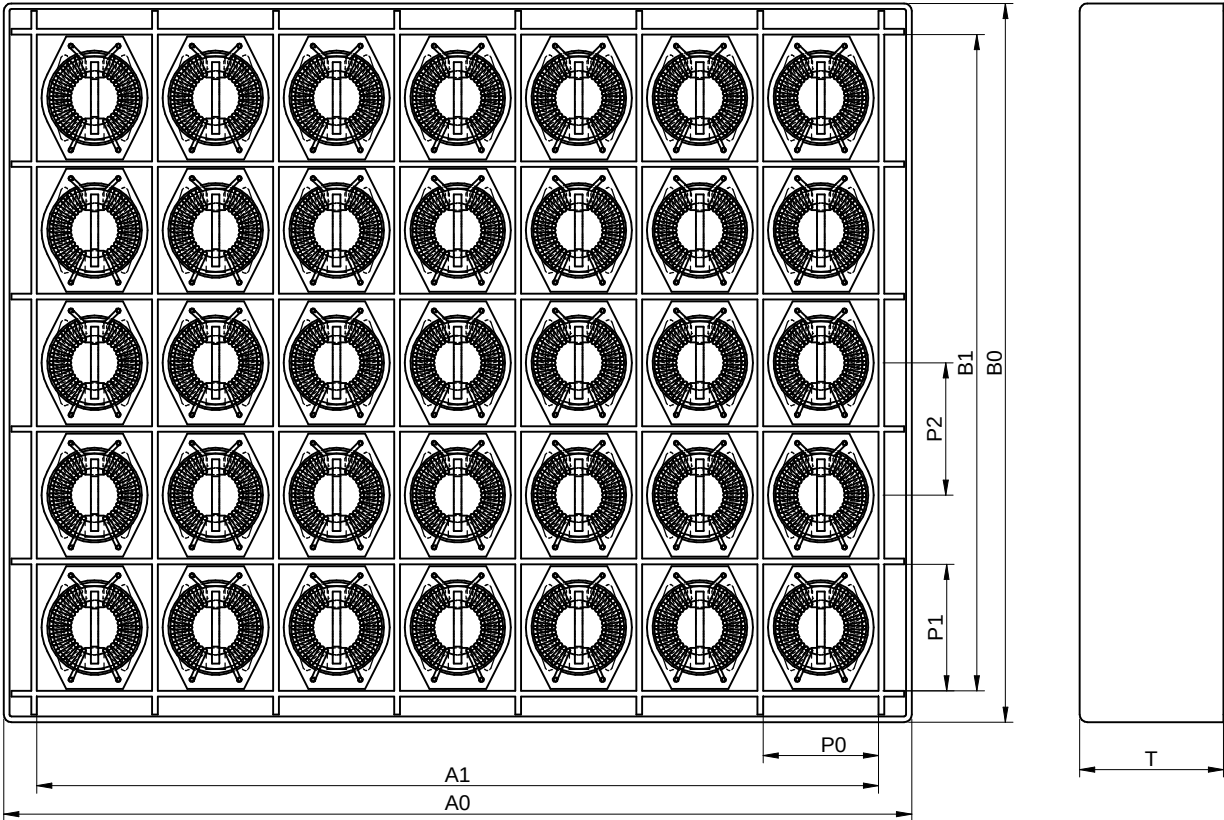
Derating Curve:



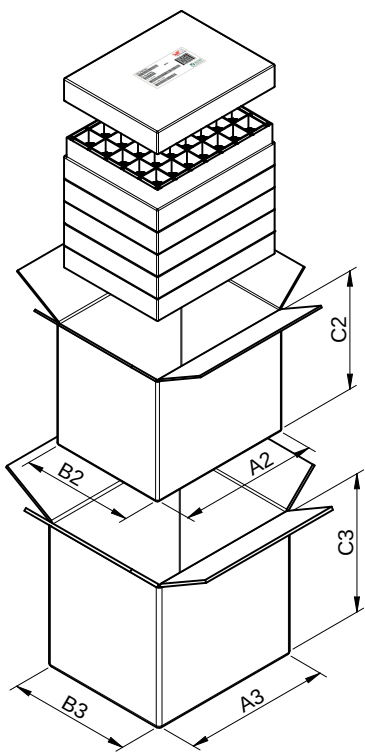
