Typical Inductance vs. Current Characteristics:



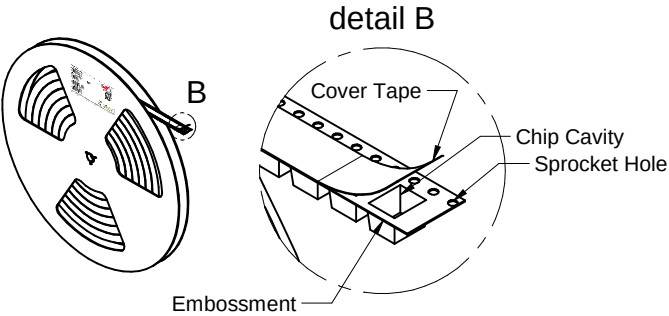
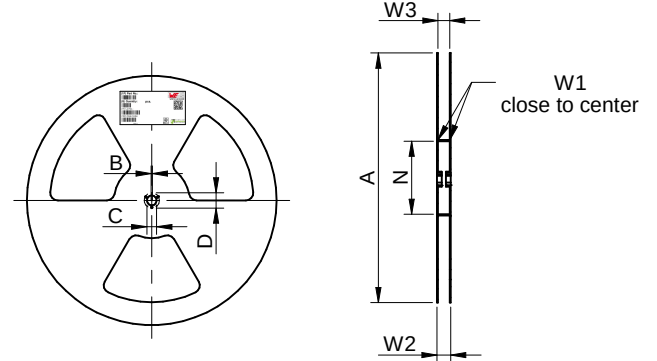
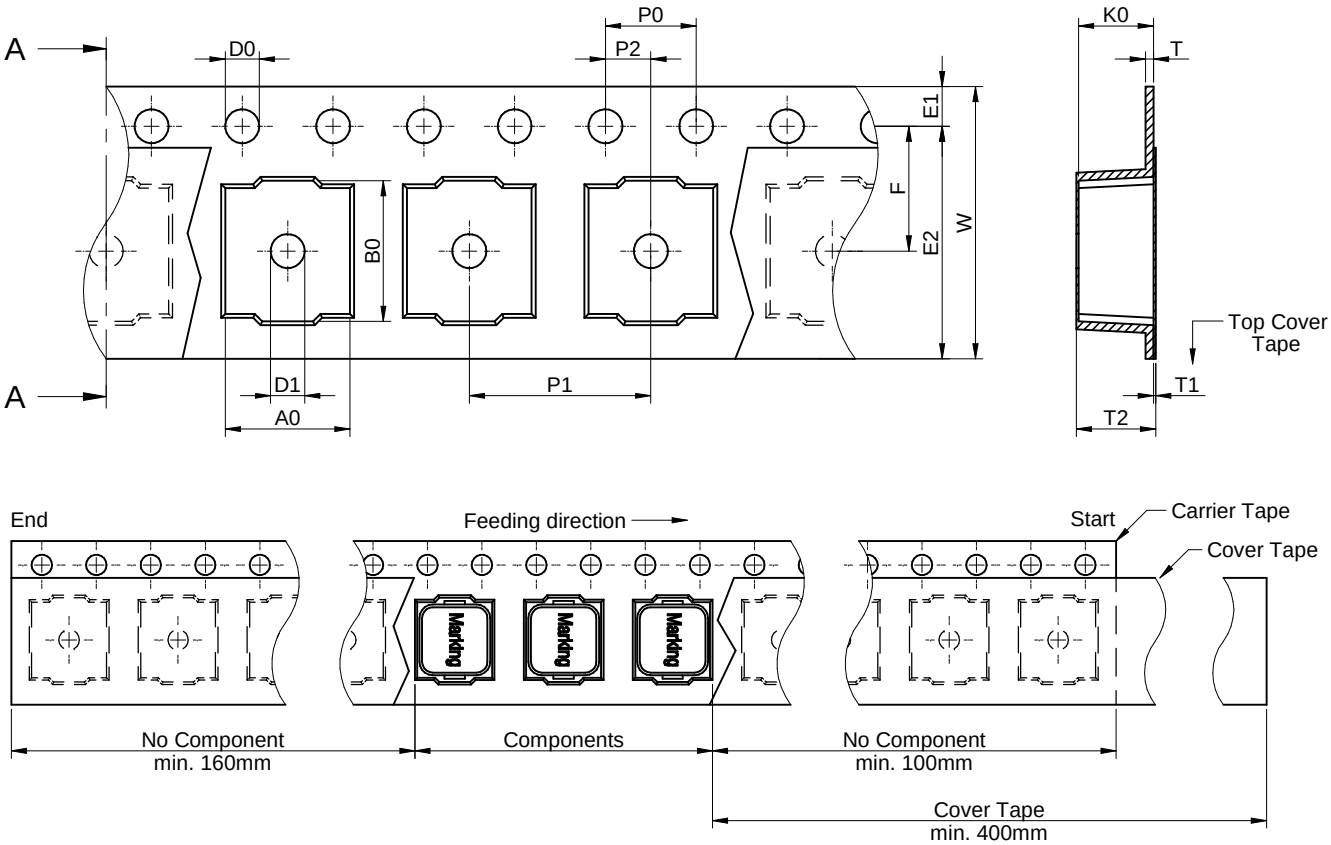
Typical Temperature Rise vs. Current Characteristics:

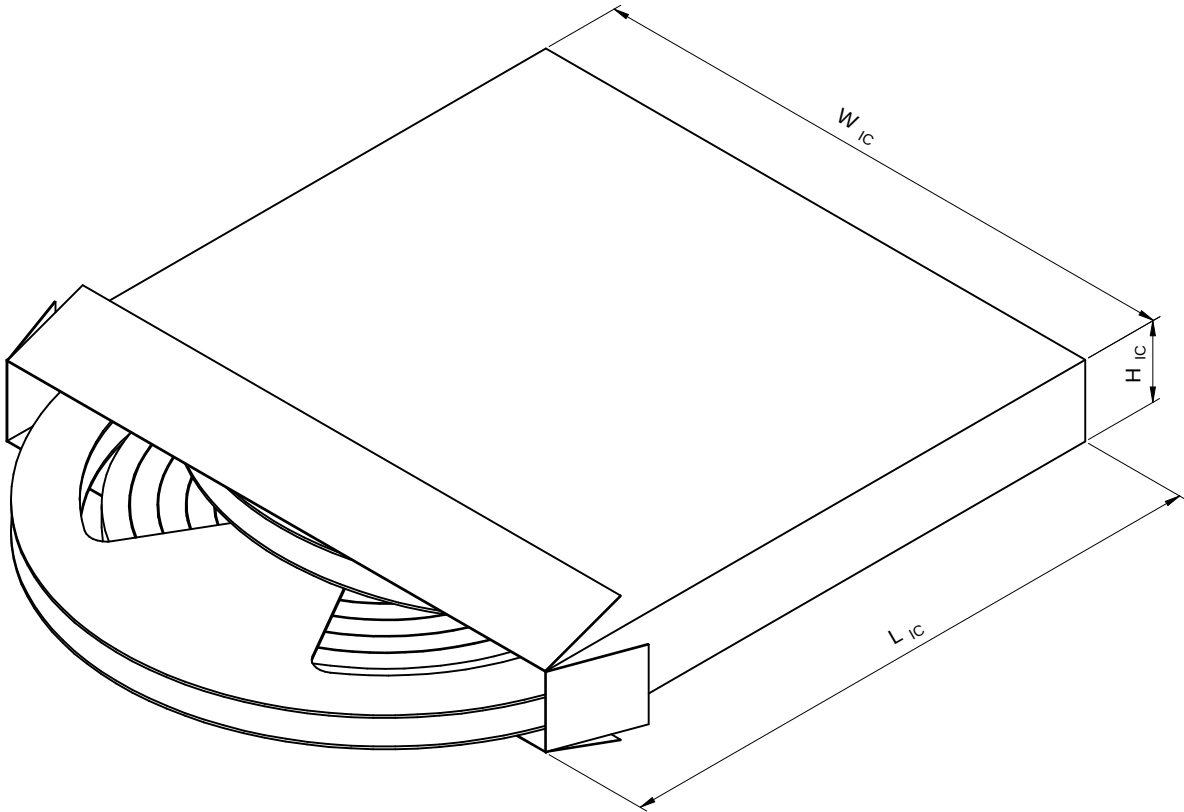

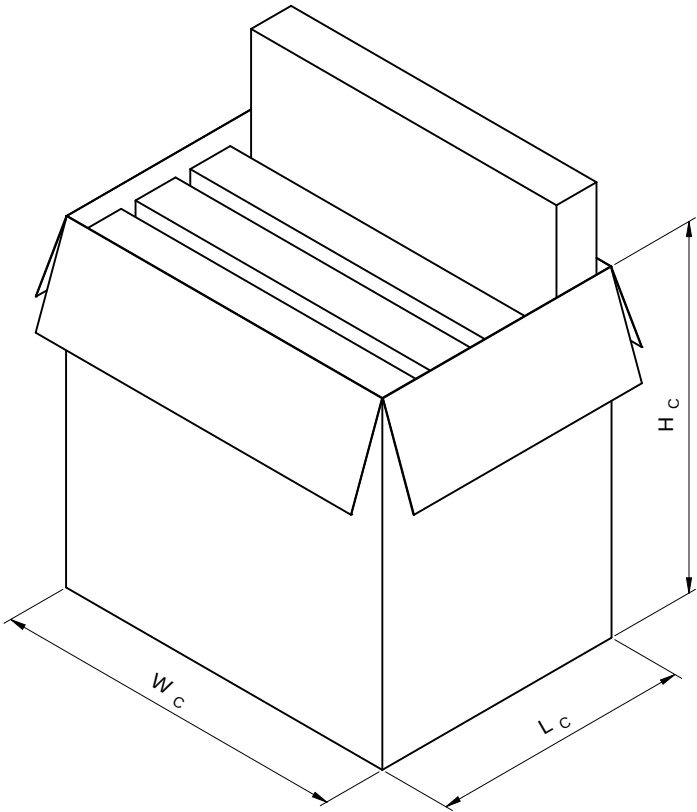

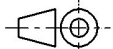

### Soldering:

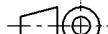

### 6. Product Life Cycle

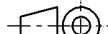
