


Figure 1 Typical Output Characteristic




Figure 2 Typical Transfer Characteristics




Figure 3 Typical On-Resistance vs. Drain Current and Temperature




Figure 4 On-Resistance Variation with Temperature




Figure 5 On-Resistance Variation with Temperature




Figure 6 Gate Threshold Variation vs. Ambient Temperature




Figure 7 Diode Forward Voltage vs. Current




Figure 8 Typical Drain-Source Leakage Current vs. Voltage




Figure 9 Typical Junction Capacitance





Figure 10 Gate Charge


