ABSTRACT

This user's guide contains information for the TPS562210A as well as support documentation for the TPS562210AEVM-663 evaluation module. Included are the performance specifications, schematic, and the bill of materials (BOM) of the TPS562210AEVM-663.

1 Introduction

The TPS562210A is a single, adaptive on-time, D-CAP2™ mode, synchronous buck converter requiring a very low external component count. The D-CAP2 control circuit is optimized for low-ESR output capacitors such as POSCAP, SP-CAP, or ceramic types and features fast transient response with no external compensation. The slow start time is externally programmable and there is a dedicated Power Good (PG) pin to aid in voltage monitoring and sequencing. The switching frequency is internally set at a nominal 650 kHz and enters Advanced Eco-mode in light load conditions. The high-side and low-side switching MOSFETs are incorporated inside the TPS562210A package along with the gate-drive circuitry. The low drain-to-source on resistance of the MOSFETs allows the TPS562210A to achieve high efficiencies and helps keep the junction temperature low at high output currents. The TPS562210A dc/dc synchronous converter is designed to provide up to a 2-A output from an input voltage source of 4.5 V to 17 V. The output voltage range is from 0.8 V to 6.5 V. Rated input voltage and output current ranges for the evaluation module are given in [Table 1-1](#).

The TPS562210AEVM-663 evaluation module (EVM) is a single, synchronous buck converter providing 1.05 V at 2 A from 4.5-V to 17-V input. This user's guide describes the TPS562210AEVM-663 performance.

2 Performance Specification Summary

A summary of the TPS562210AEVM-663 performance specifications is provided in [Table 2-1](#). Specifications are given for an input voltage of $V_{IN} = 12\text{ V}$ and an output voltage of 1.05 V , unless otherwise noted. The ambient temperature is 25°C for all measurement, unless otherwise noted.

3 Modifications

These evaluation modules are designed to provide access to the features of the TPS562210A. Some modifications can be made to this module.

3.1 Output Voltage Setpoint

To change the output voltage of the EVMs, it is necessary to change the value of resistor R1. Changing the value of R1 can change the output voltage above 0.765 V. The value of R1 for a specific output voltage can be calculated using [Equation 1](#).

$$R1 = \frac{R2 \times (V_{OUT} - 0.765 \text{ V})}{0.765 \text{ V}} \quad (1)$$

[Table 3-1](#) lists the R1 values for some common output voltages. Note that the values given in [Table 3-1](#) are standard values and not the exact value calculated using [Table 3-1](#).

4 Test Setup and Results

This section describes how to properly connect, set up, and use the TPS562210AEVM-663. The section also includes test results typical for the evaluation modules and efficiency, output load regulation, output line regulation, load transient response, output voltage ripple, input voltage ripple, start-up, and switching frequency.

4.1 Input/Output Connections

The TPS562210AEVM-663 is provided with input/output connectors and test points as shown in [Table 4-1](#). A power supply capable of supplying 2 A must be connected to J1 through a pair of 20-AWG wires. The load must be connected to J2 through a pair of 20-AWG wires. The maximum load current capability is 2 A. Wire lengths must be minimized to reduce losses in the wires. Test point TP1 provides a place to monitor the V_{IN} input voltages with TP2 providing a convenient ground reference. TP7 is used to monitor the output voltage with TP8 as the ground reference.

4.2 Start-Up Procedure

1. Ensure that the jumper at JP1 (Enable control) pins 1 and 2 are covered to shunt EN to GND, disabling the output.
2. Apply appropriate V_{IN} voltage to VIN (J1-2) and GND (J1-1). See [Table 1-1](#) for V_{IN} voltage range.
3. Move the jumper at JP1 (Enable control) from pins 1 and 2 (EN and GND), to pins 2 and 3 (EN and V_{IN}) enabling the output.

4.3 Efficiency

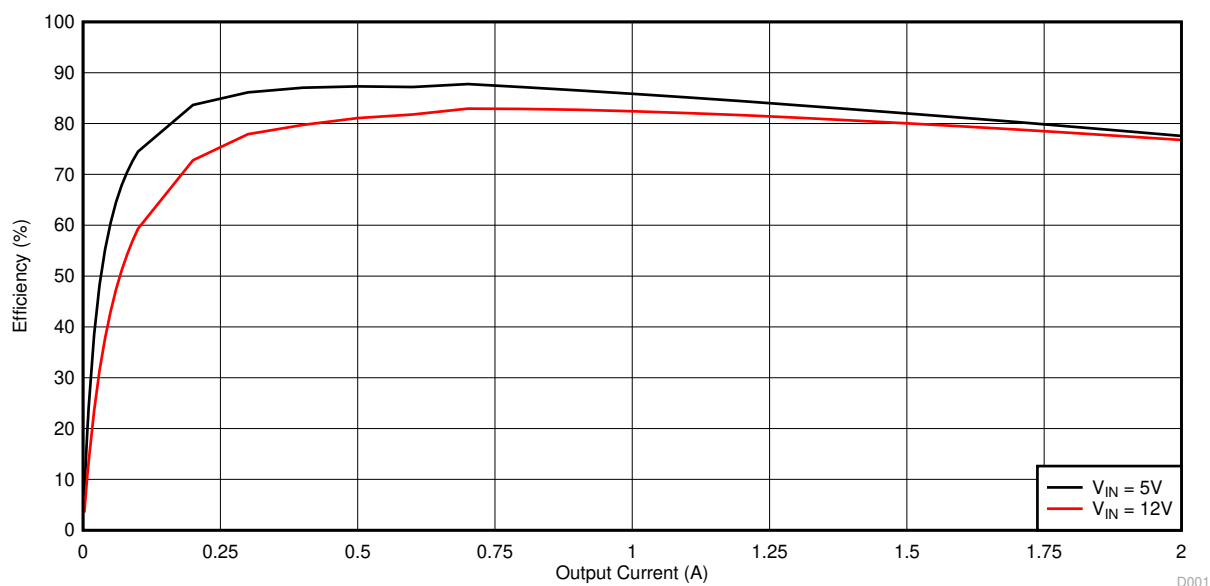


Figure 4-1. TPS562210AEVM-663 Efficiency

Figure 4-1 shows the efficiency for the TPS562210AEVM-663 at an ambient temperature of 25°C.

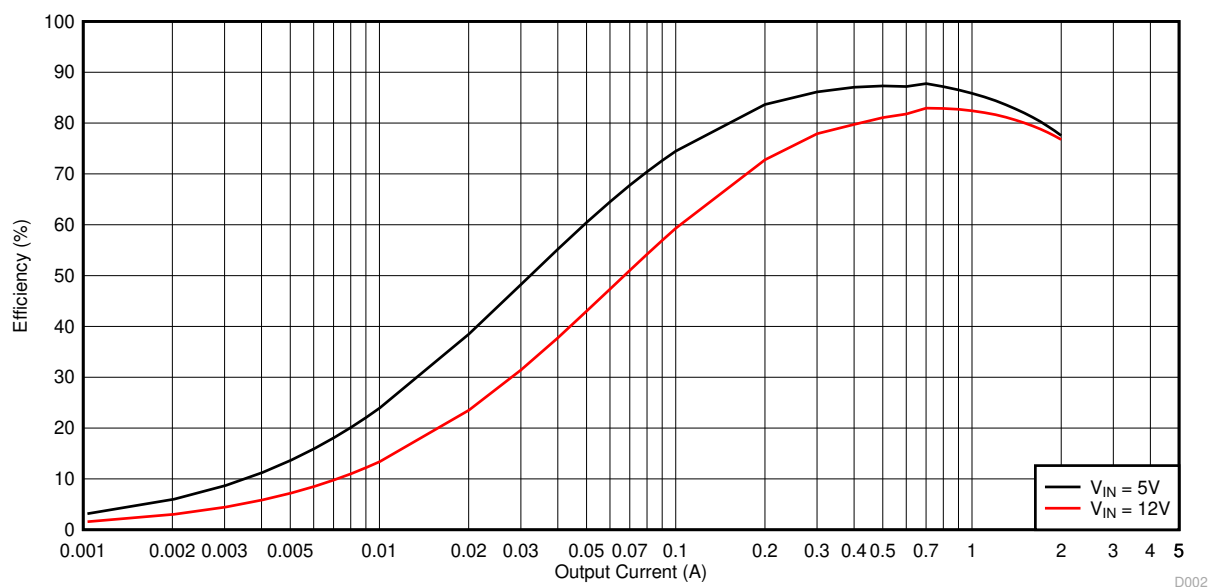


Figure 4-2. TPS562210AEVM-663 Light Load Efficiency

Figure 4-2 shows the efficiency at light loads for the TPS562210AEVM-663 at an ambient temperature of 25°C.

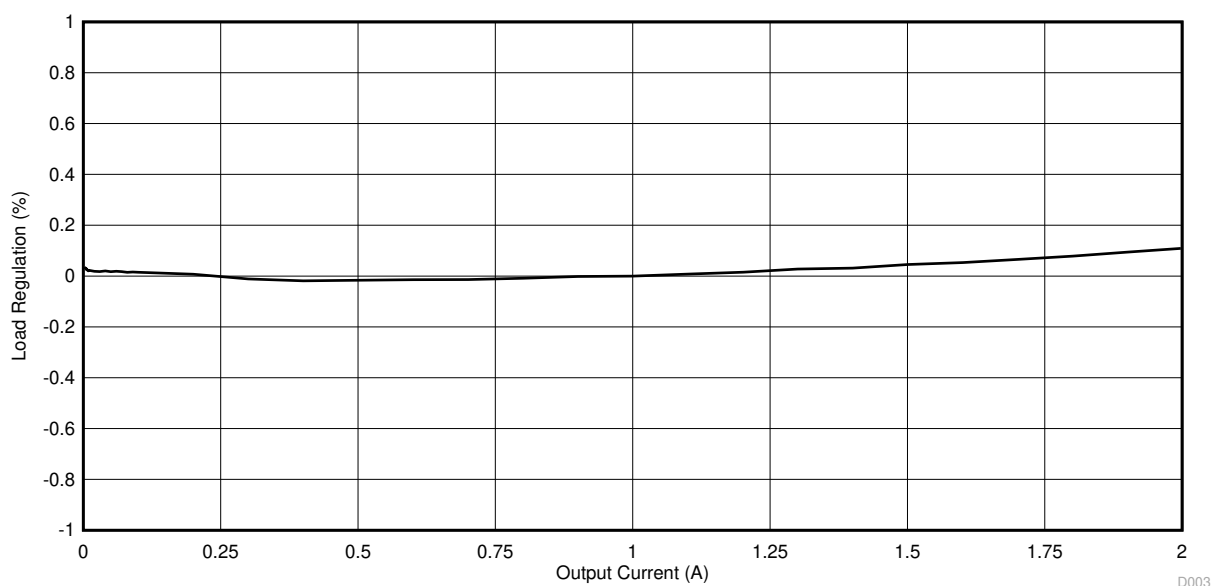


Figure 4-3. TPS562210AEVM-663 Load Regulation, 5 V Input

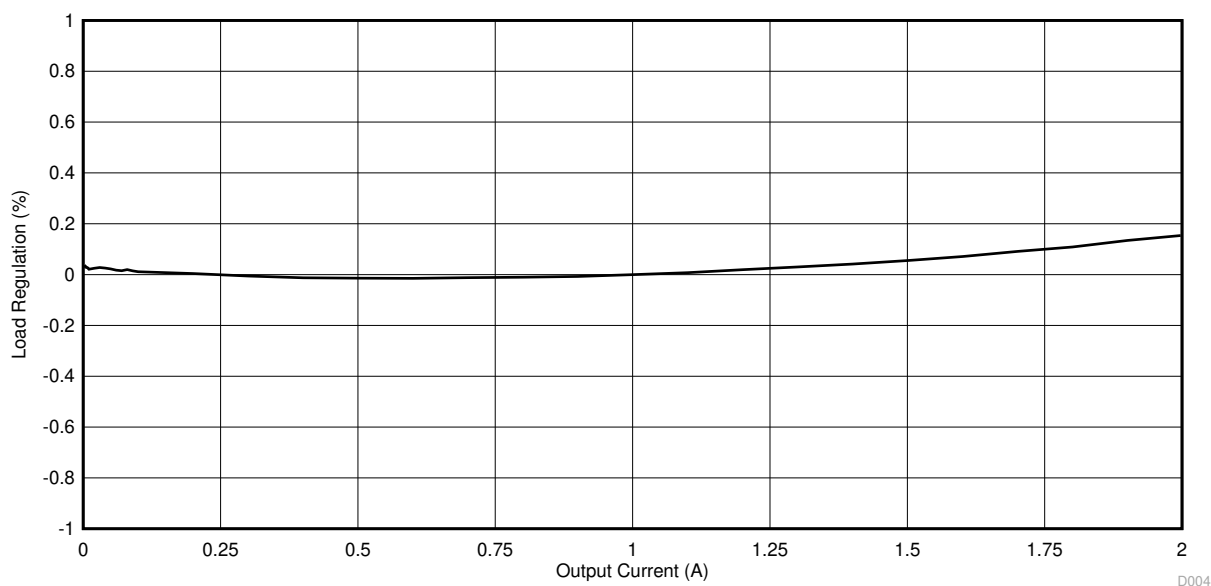


Figure 4-4. TPS562210AEVM-663 Load Regulation, 12 V Input

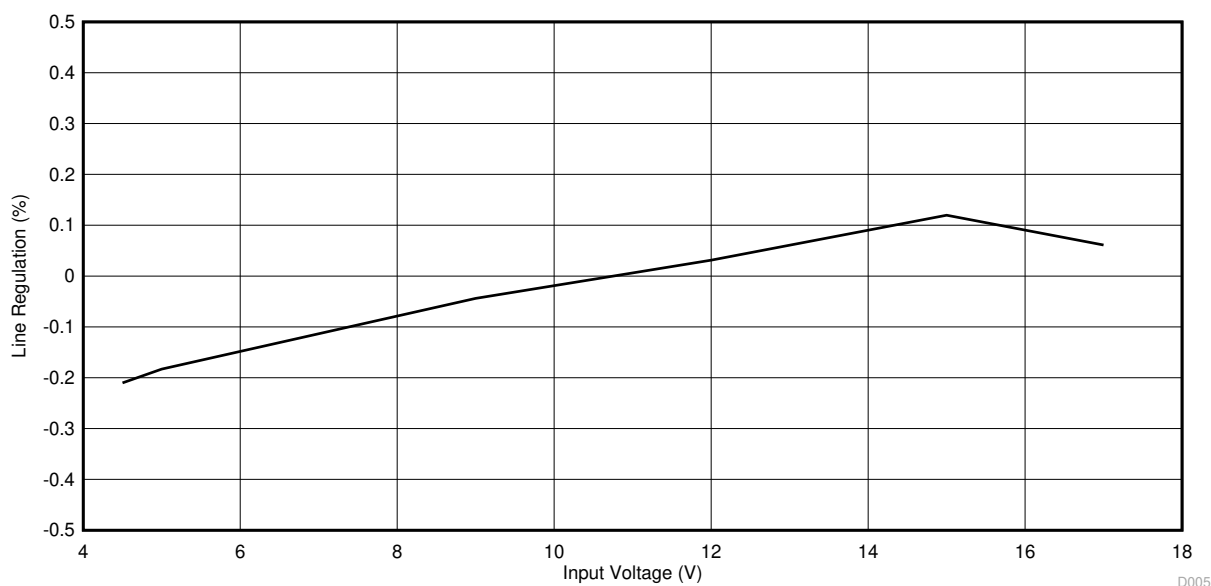


Figure 4-5. TPS562210AEVM-663 Line Regulation

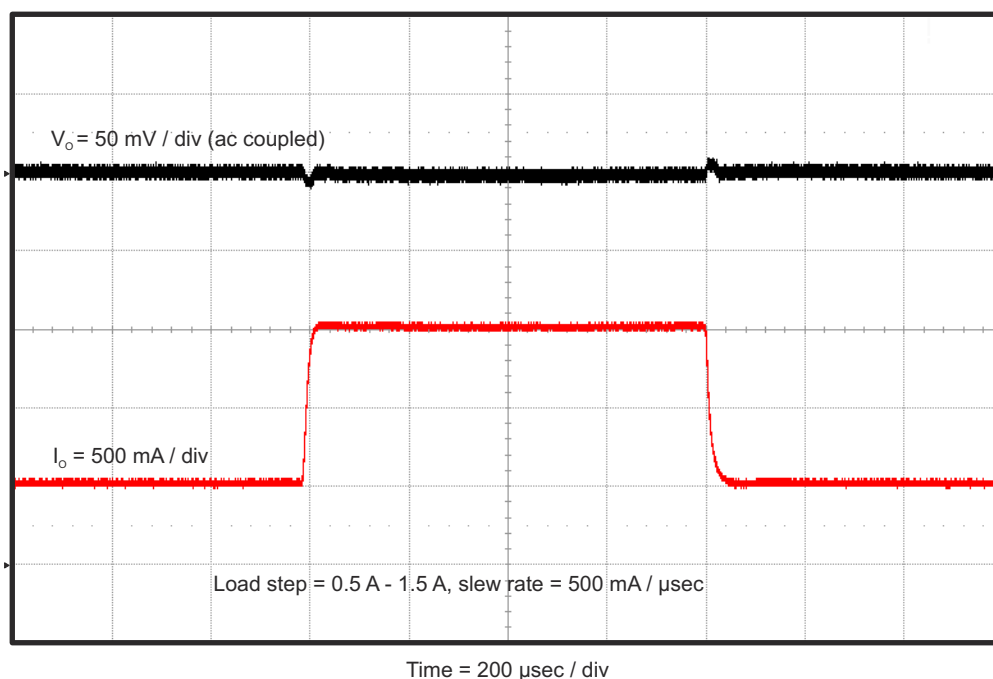


Figure 4-6. TPS562210AEVM-663 Load Transient Response, 25% to 75% Load Step

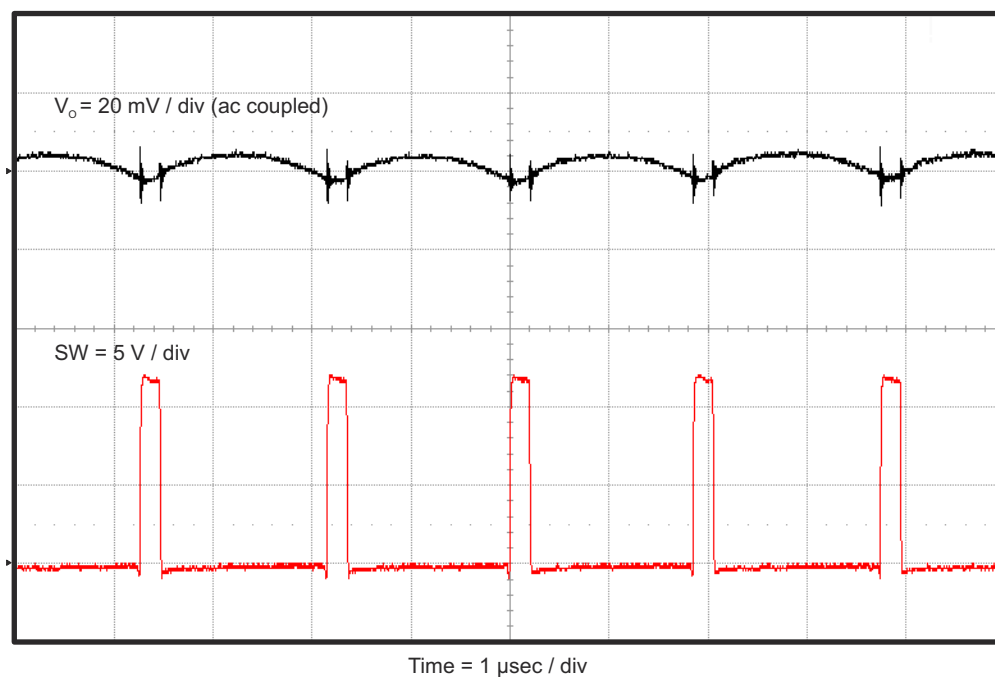


Figure 4-7. TPS562210AEVM-663 Output Voltage Ripple, $I_{OUT} = 2$ A

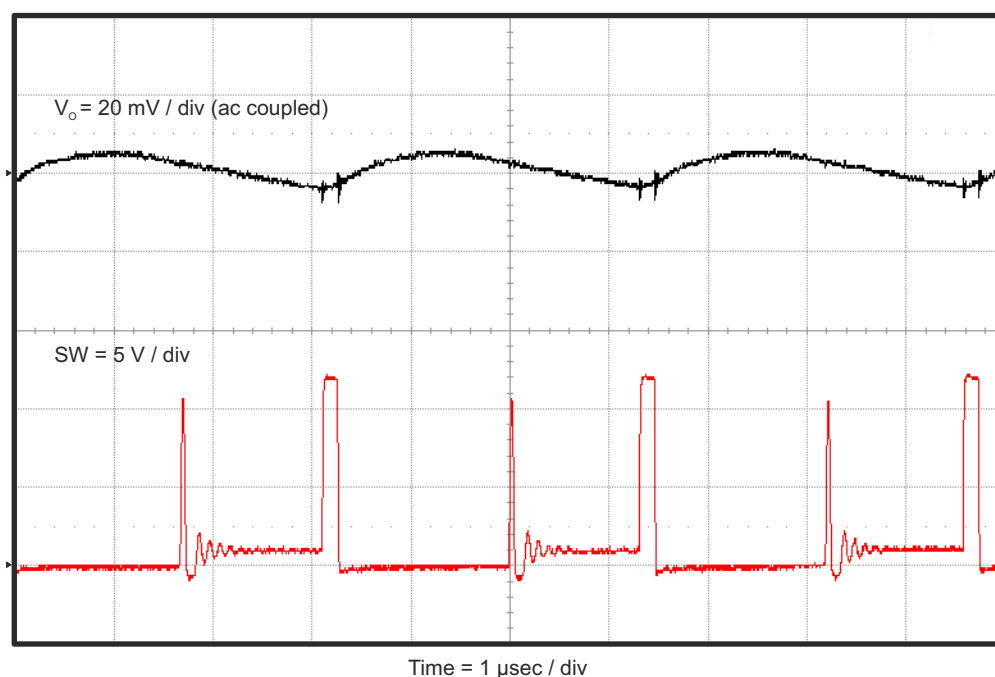


Figure 4-8. TPS562210AEVM-663 Output Voltage Ripple, $I_{OUT} = 200$ mA

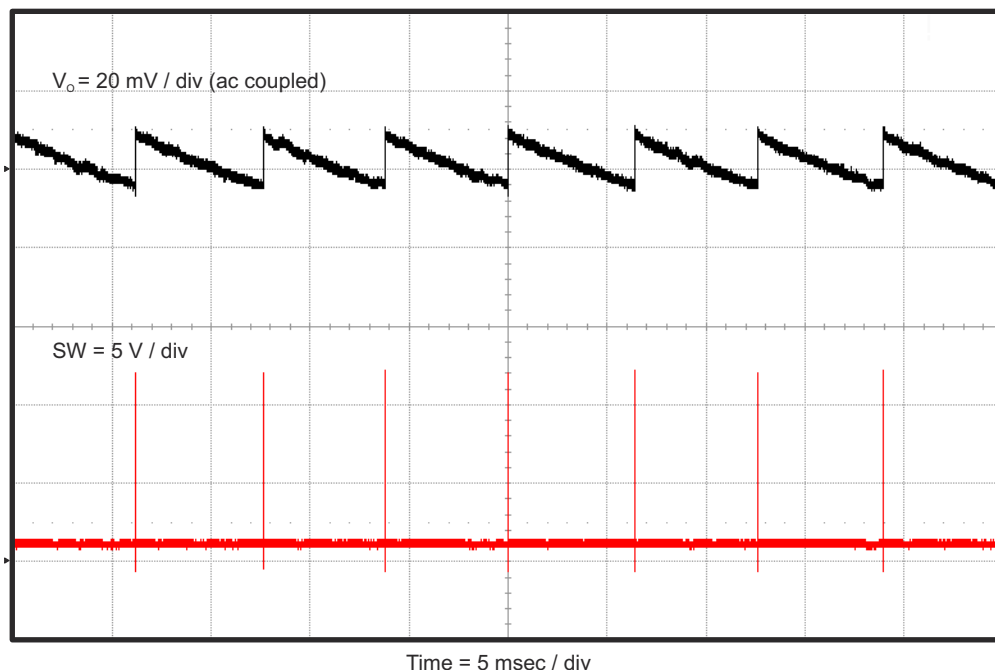


Figure 4-9. TPS562210AEVM-663 Output Voltage Ripple, $I_{OUT} = 0$ mA

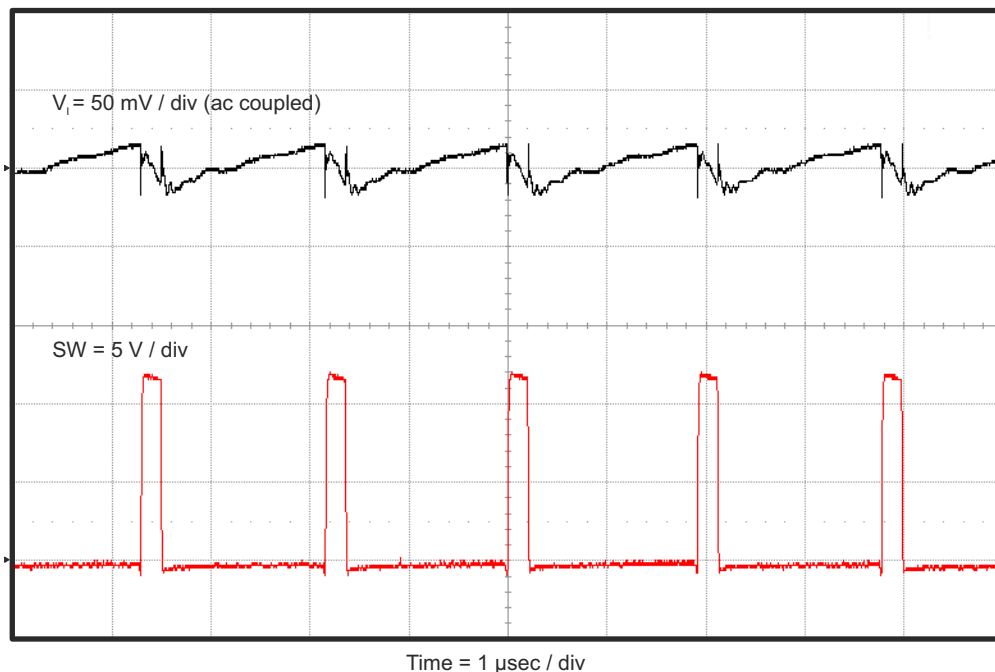


Figure 4-10. TPS562210AEVM-663 Input Voltage Ripple, $I_{OUT} = 2$ A

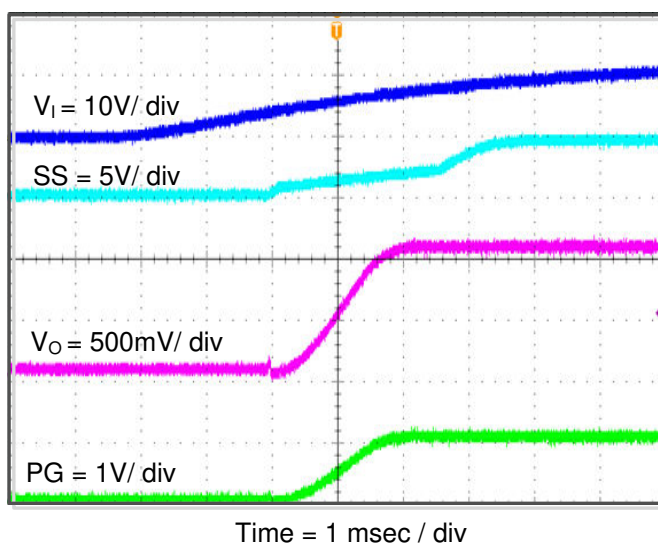


Figure 4-11. TPS562210AEVM-663 Start-Up Relative to V_{IN}

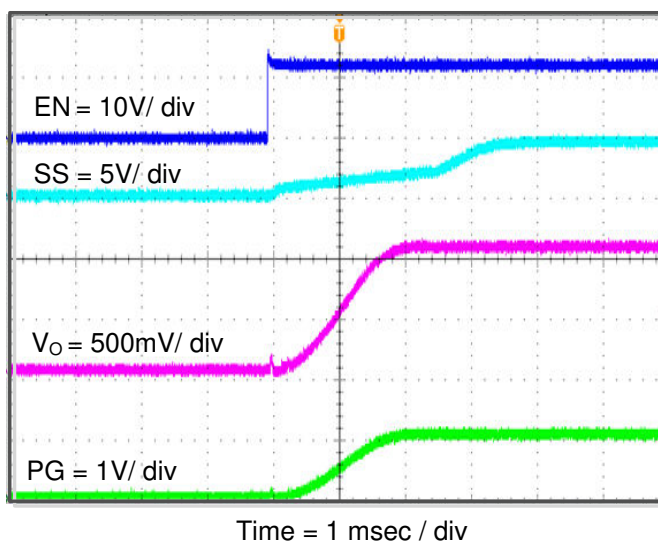


Figure 4-12. TPS562210AEVM-663 Start-Up Relative to EN

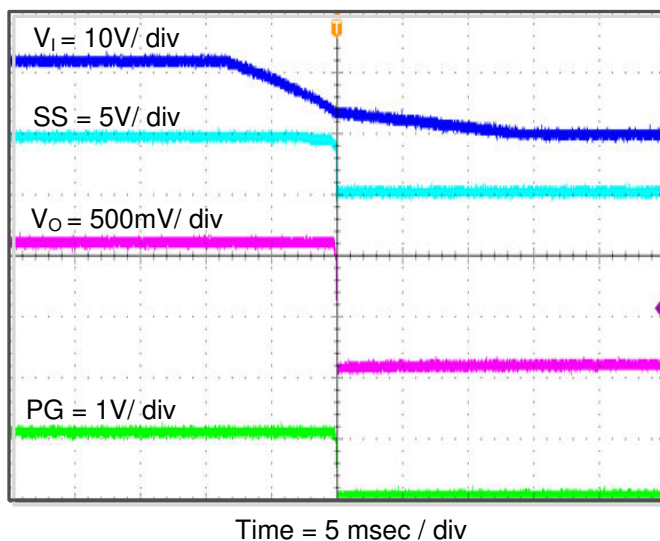


Figure 4-13. TPS562210AEVM-663 Shut-Down Relative to V_{IN}

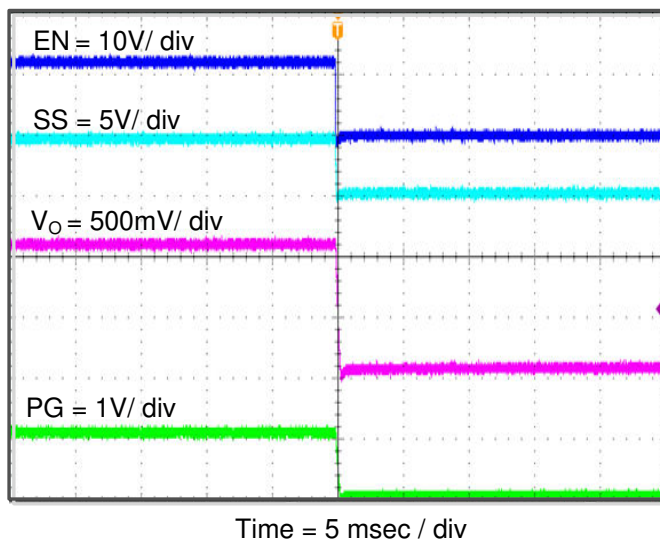


Figure 4-14. TPS562210AEVM-663 Shut-Down Relative to EN

5 Board Layout

This section provides a description of the TPS562210AEVM-663, board layout, and layer illustrations.

5.1 Layout

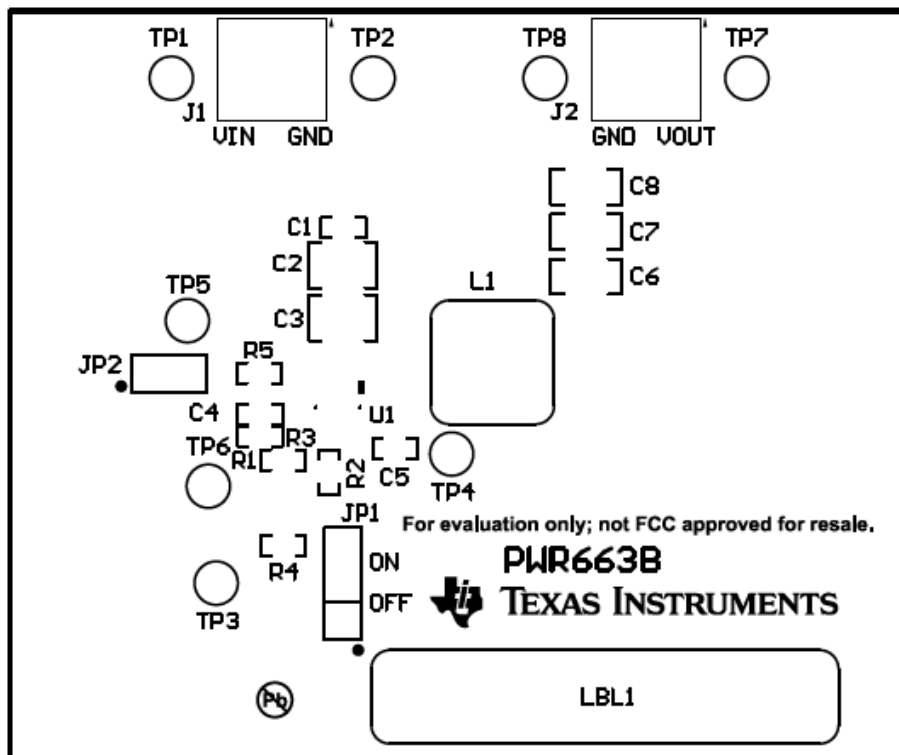


Figure 5-1. Top Assembly

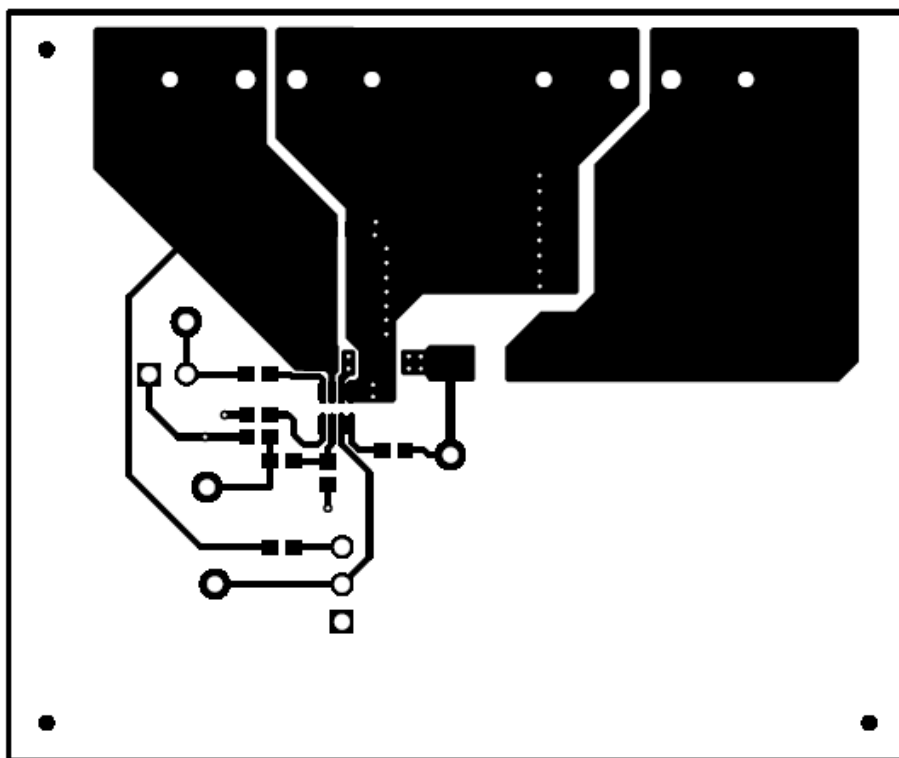


Figure 5-2. Top Layer

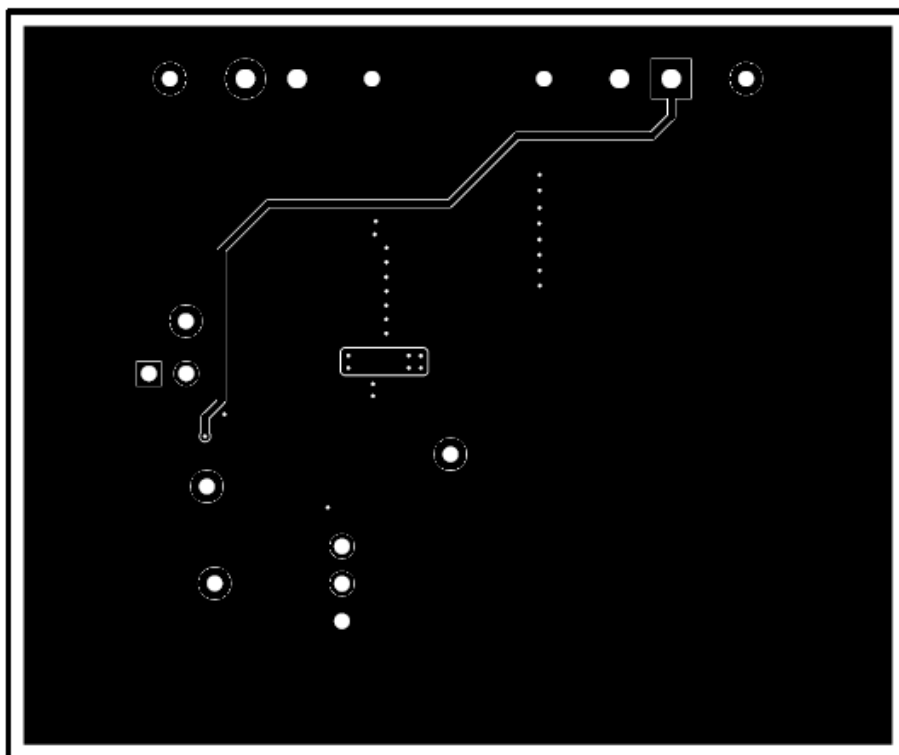
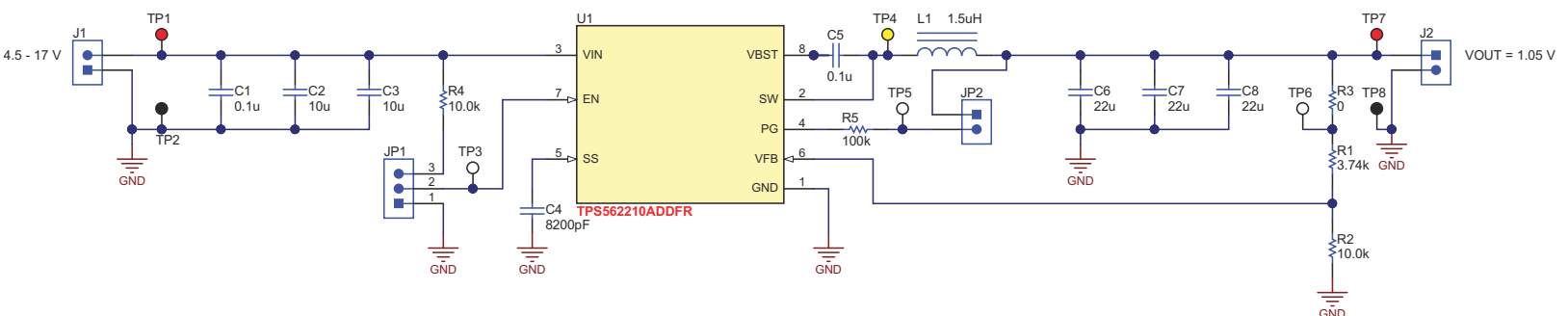


Figure 5-3. Bottom Layer

The board layout for the TPS562210AEVM-663 is shown in [Figure 5-1](#), [Figure 5-2](#), and [Figure 5-3](#). The top layer contains the main power traces for VIN, VOUT, and ground. Also on the top layer are connections for the pins of the TPS562210A and a large area filled with ground. Most of the signal traces are also located on the top side. The input decoupling capacitors, C1, C2, and C3 are located as close to the IC as possible. The input and output connectors, test points, and all of the components are located on the top side. The bottom layer is a ground plane along with the switching node copper fill, signal ground copper fill and the feed back trace from the point of regulation to the top of the resistor divider network.
