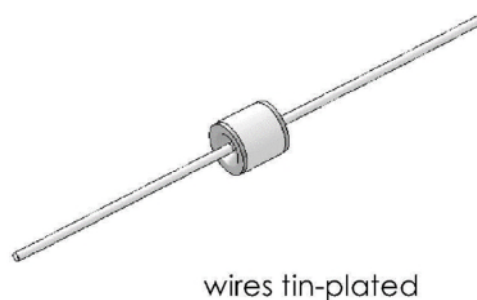
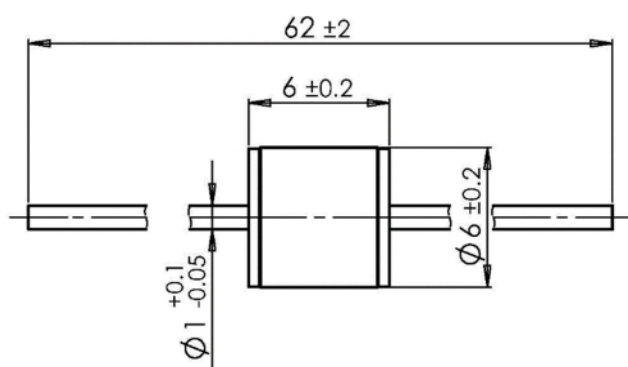

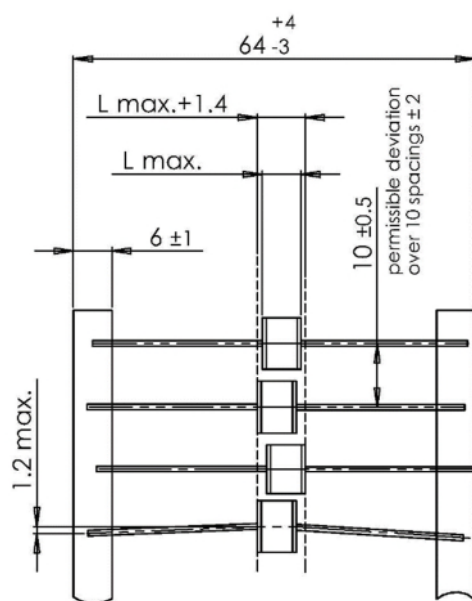

Dimensional drawing in mm

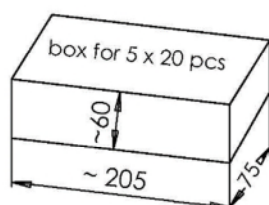
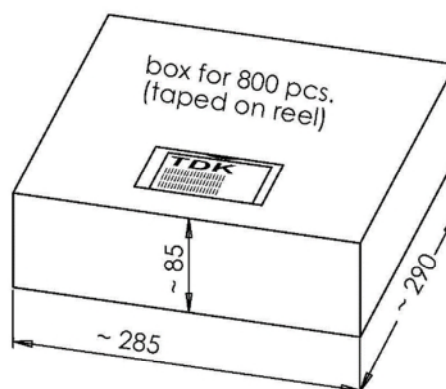
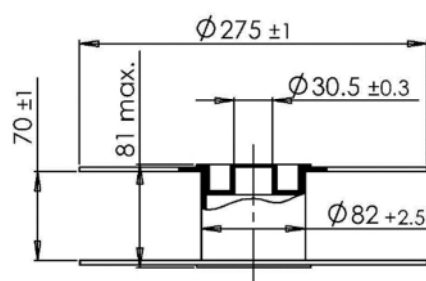

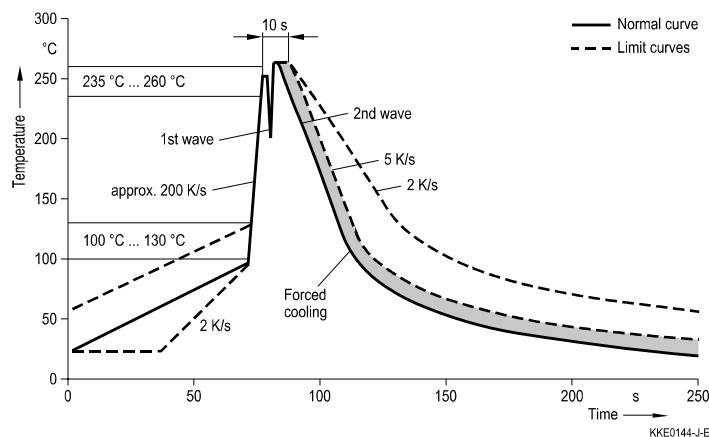

Cautions and warnings
