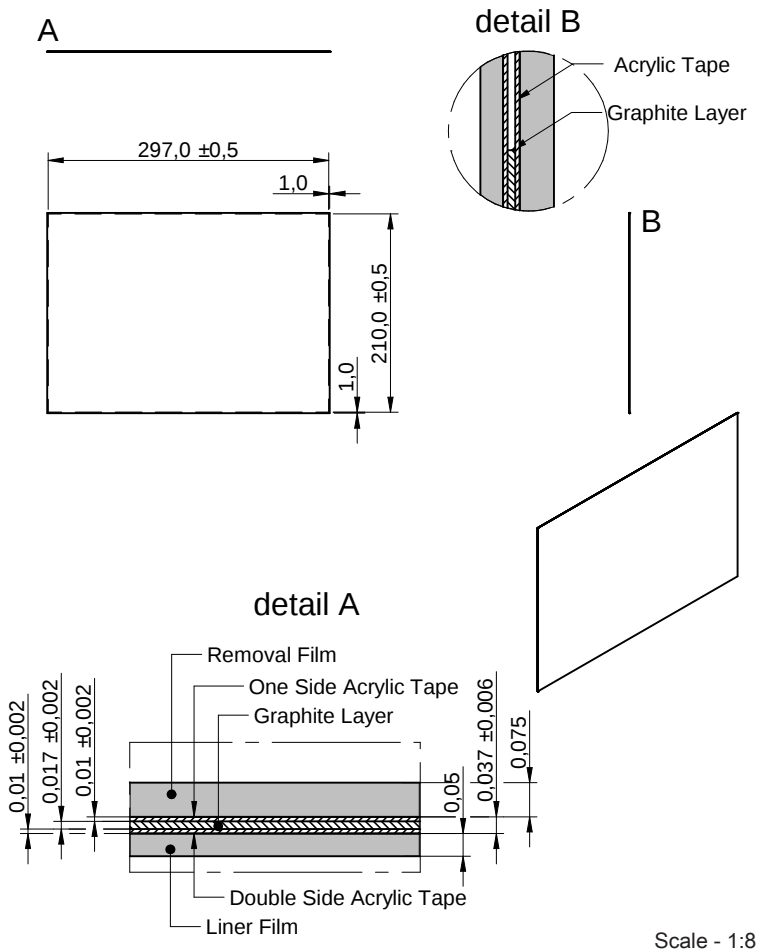

Product Specific:

Cleaning and Washing:

6. Product Life Cycle

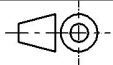
