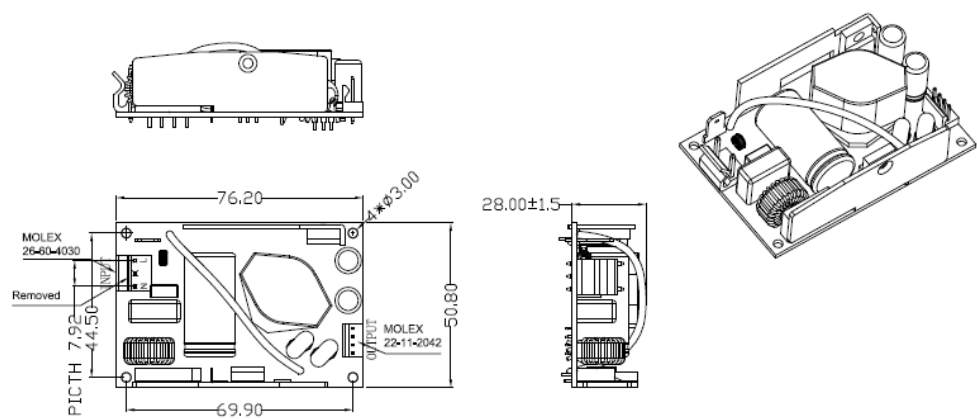

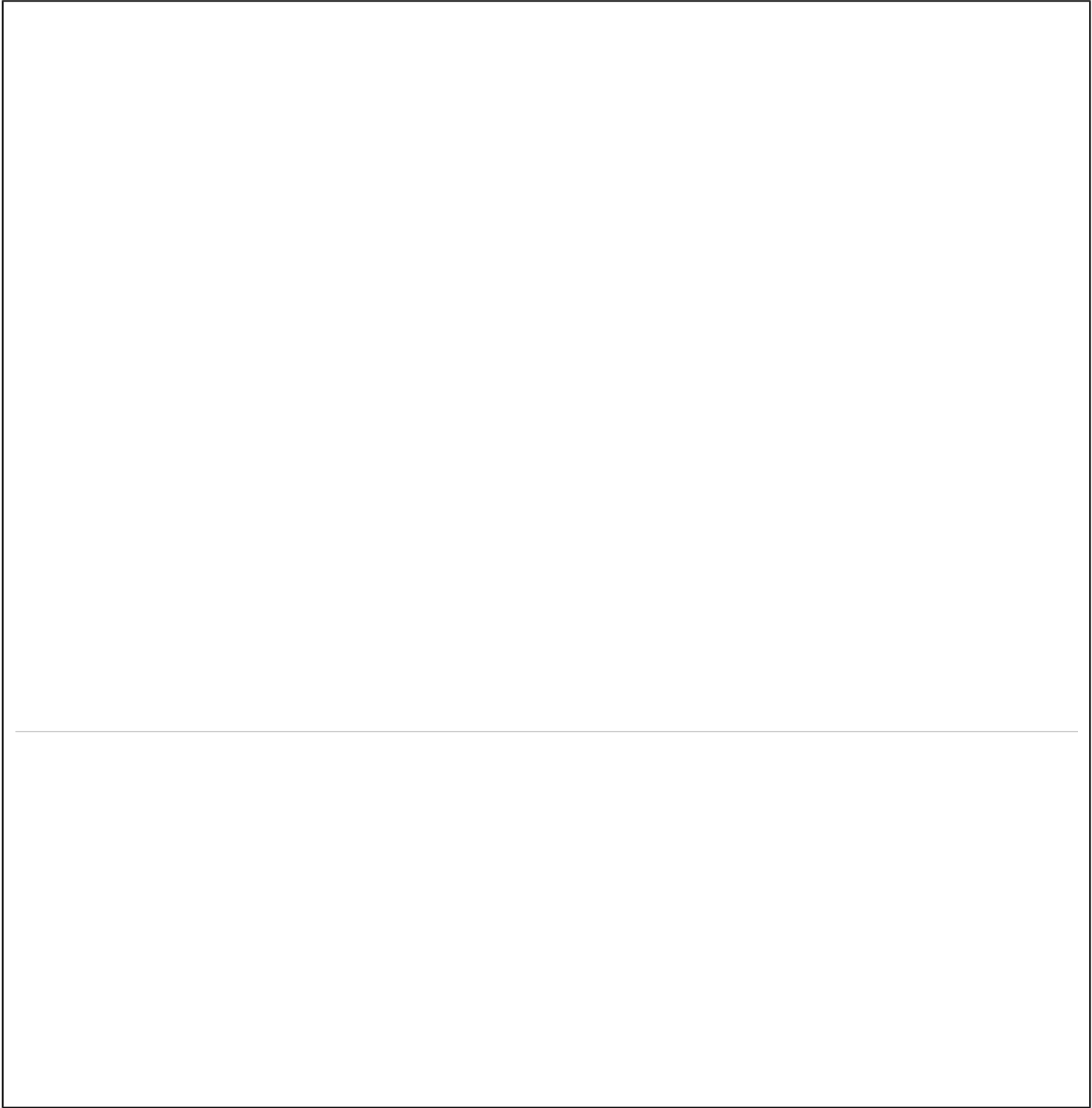

DERATING CURVE



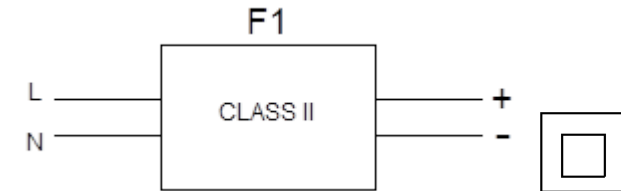
