Typical Impedance Characteristics:



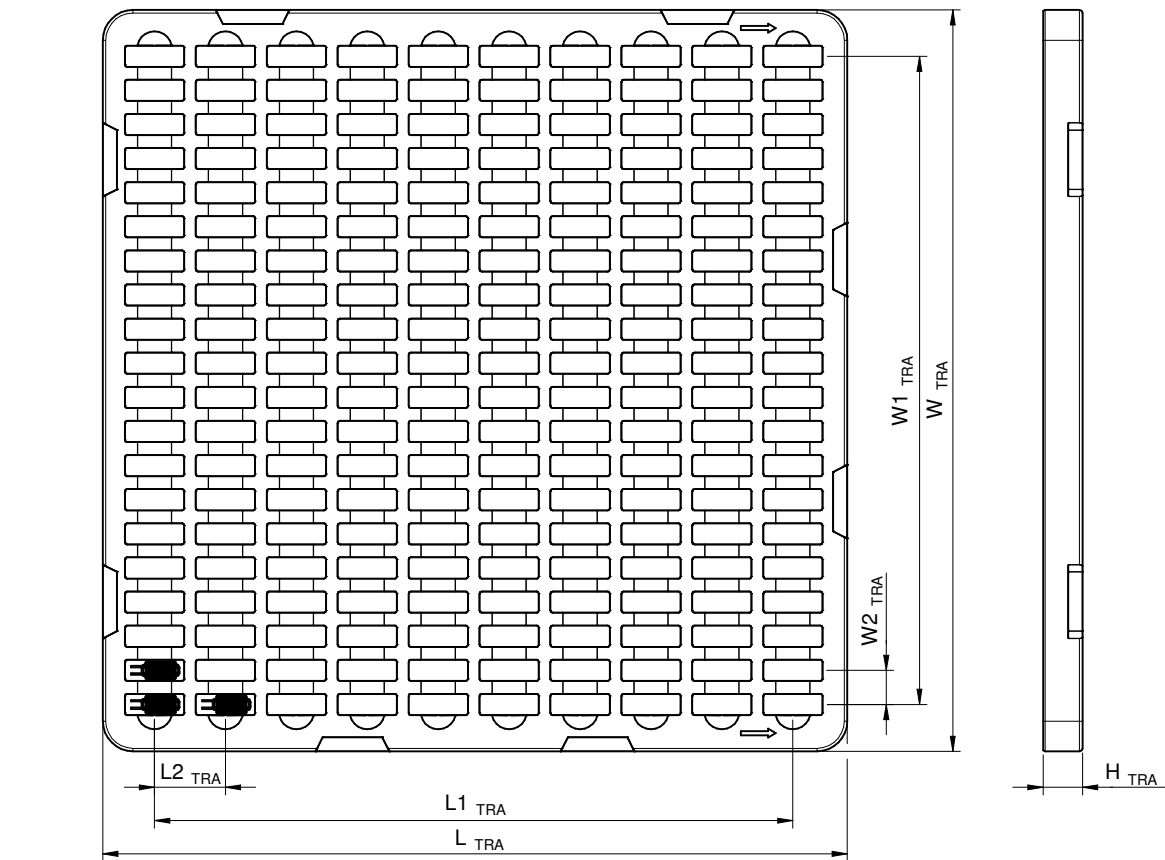

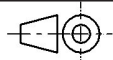
