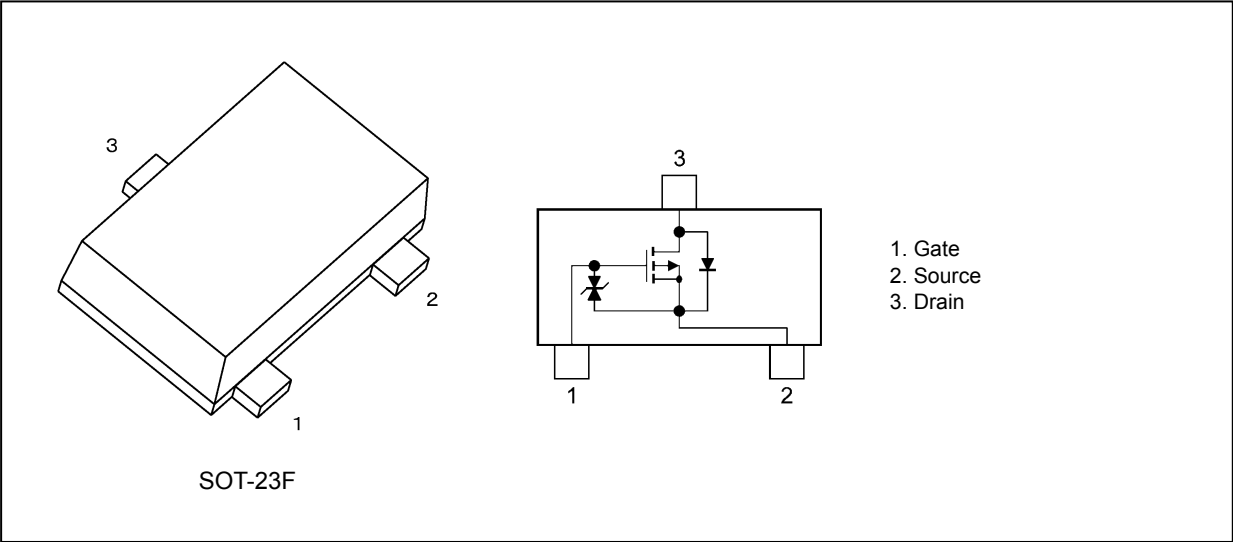

Note 1: If a reverse bias is applied between gate and source, this device enters $V_{(BR)DSX}$ mode. Note that the drain-source breakdown voltage is lowered in this mode.

Note 2: Let V_{th} be the voltage applied between gate and source that causes the drain current (I_D) to below (-1 mA for this device). Then, for normal switching operation, $V_{GS(ON)}$ must be higher than V_{th} , and $V_{GS(OFF)}$ must be lower than V_{th} . This relationship can be expressed as: $V_{GS(OFF)} < V_{th} < V_{GS(ON)}$.

Take this into consideration when using the device.

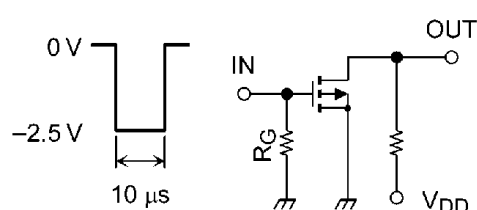


Fig. 6.3.1 Test Circuit of Switching Time

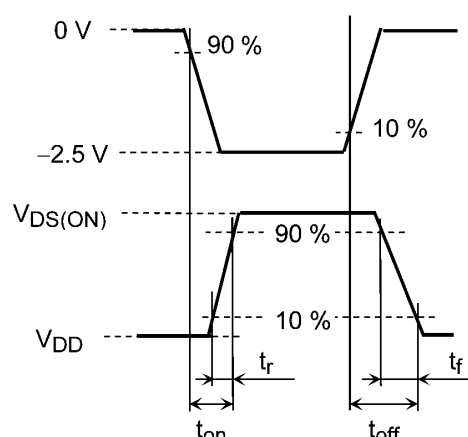


Fig. 6.3.2 Input Waveform/Output Waveform

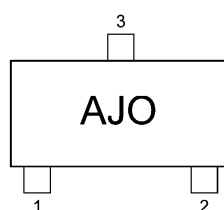


Fig. 7.1 Marking

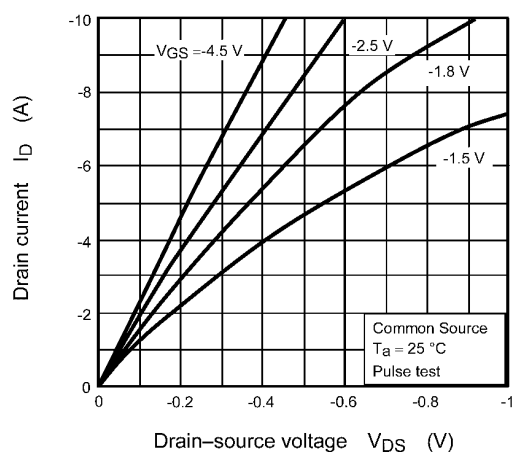


Fig. 8.1 $I_D - V_{DS}$

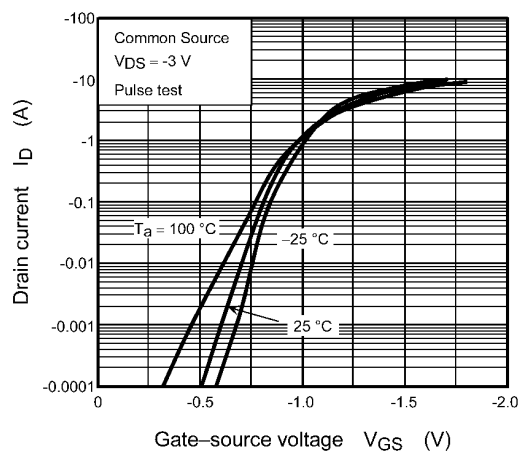


Fig. 8.2 $I_D - V_{GS}$

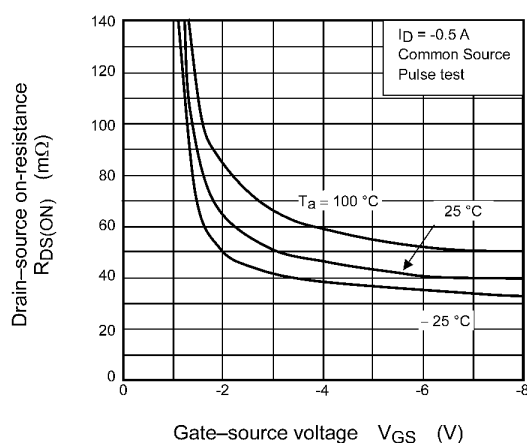


Fig. 8.3 $R_{DS(ON)} - V_{GS}$

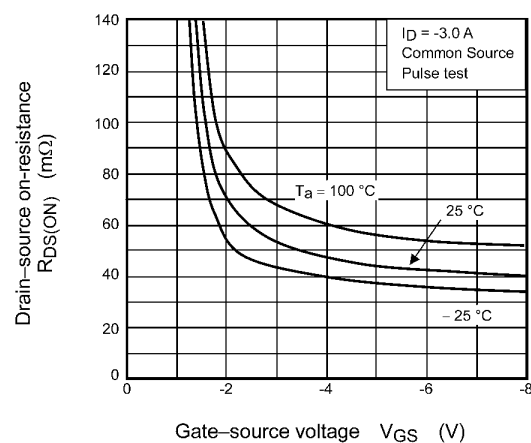


Fig. 8.4 $R_{DS(ON)} - V_{GS}$

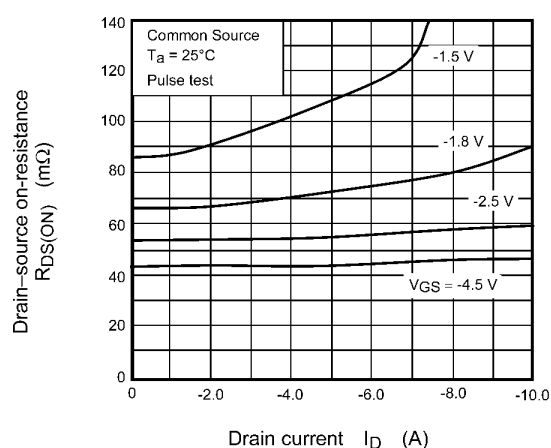


Fig. 8.5 $R_{DS(ON)} - I_D$

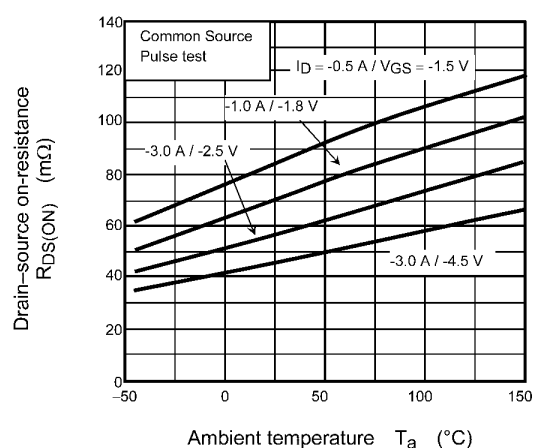


Fig. 8.6 $R_{DS(ON)} - T_a$

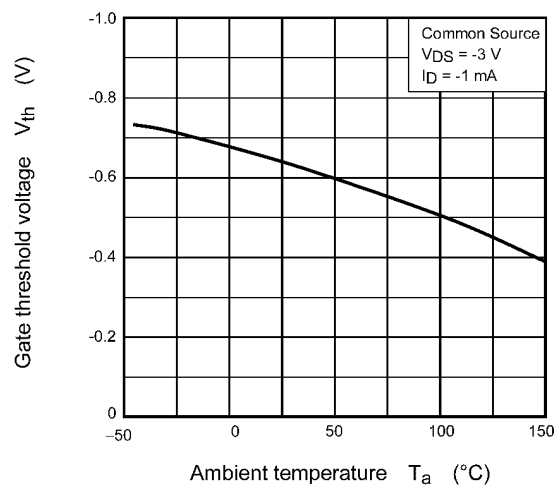


Fig. 8.7 $V_{th} - T_a$

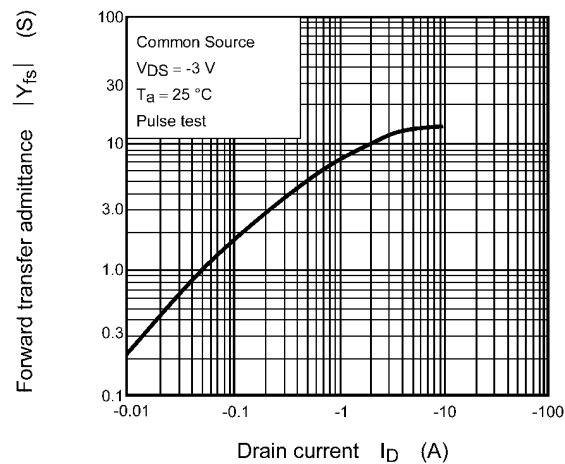


Fig. 8.8 $|Y_{fs}| - I_D$

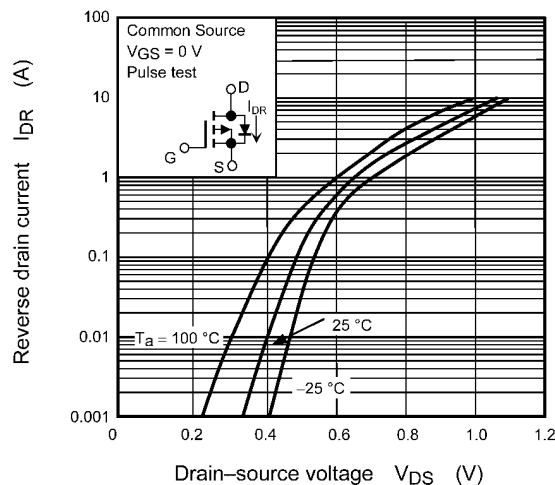


Fig. 8.9 $I_{DR} - V_{DS}$

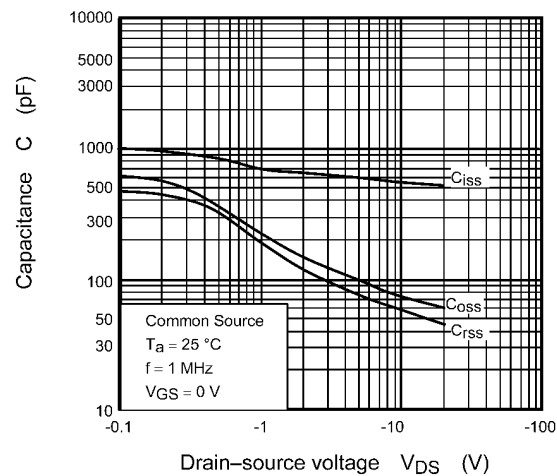


Fig. 8.10 $C - V_{DS}$

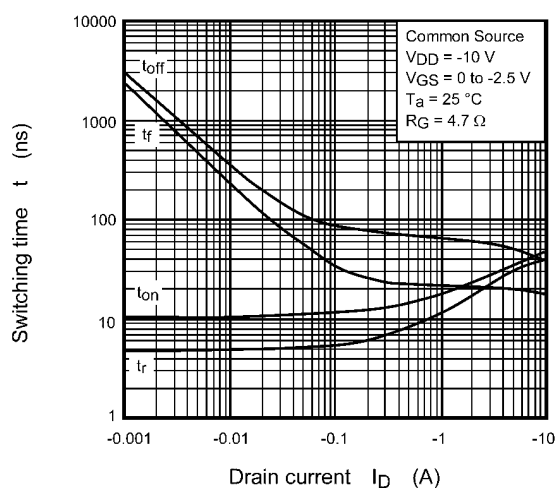


Fig. 8.11 $t - I_D$

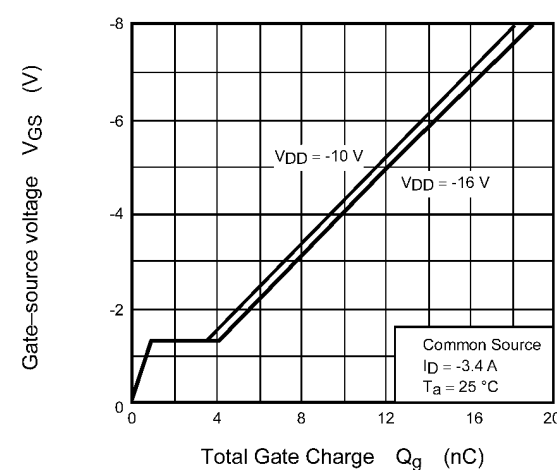


Fig. 8.12 Dynamic Input Characteristics

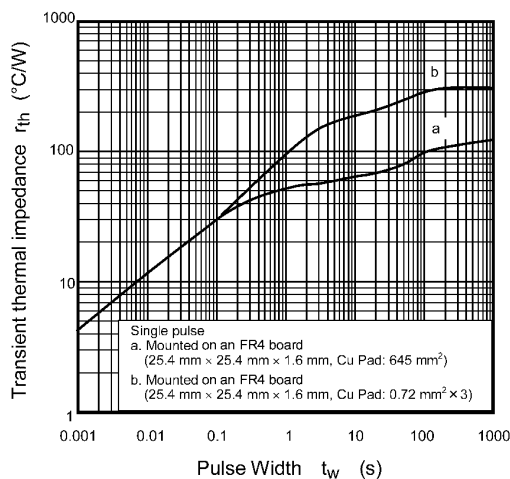


Fig. 8.13 $r_{th} - t_w$

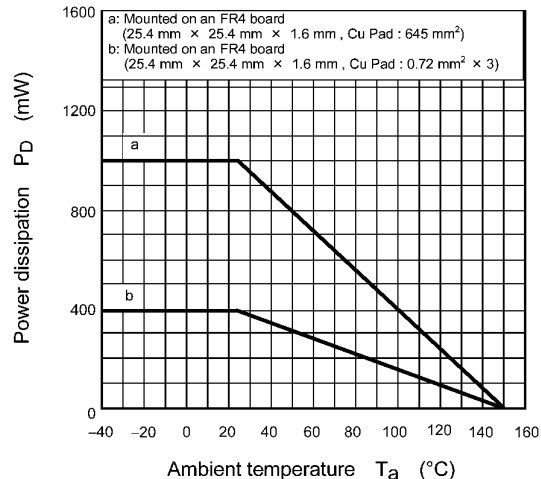


Fig. 8.14 $P_D - T_a$

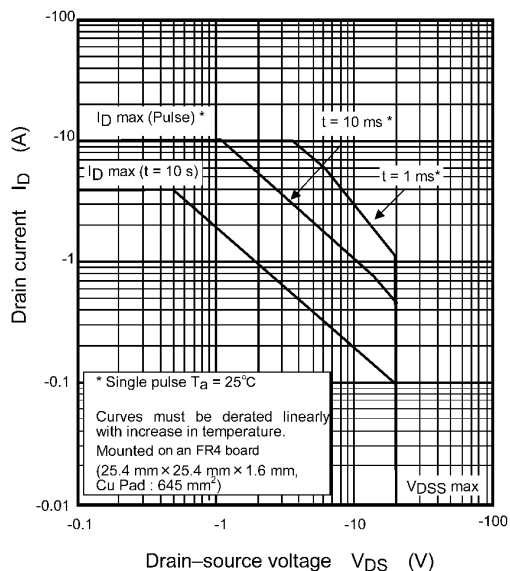
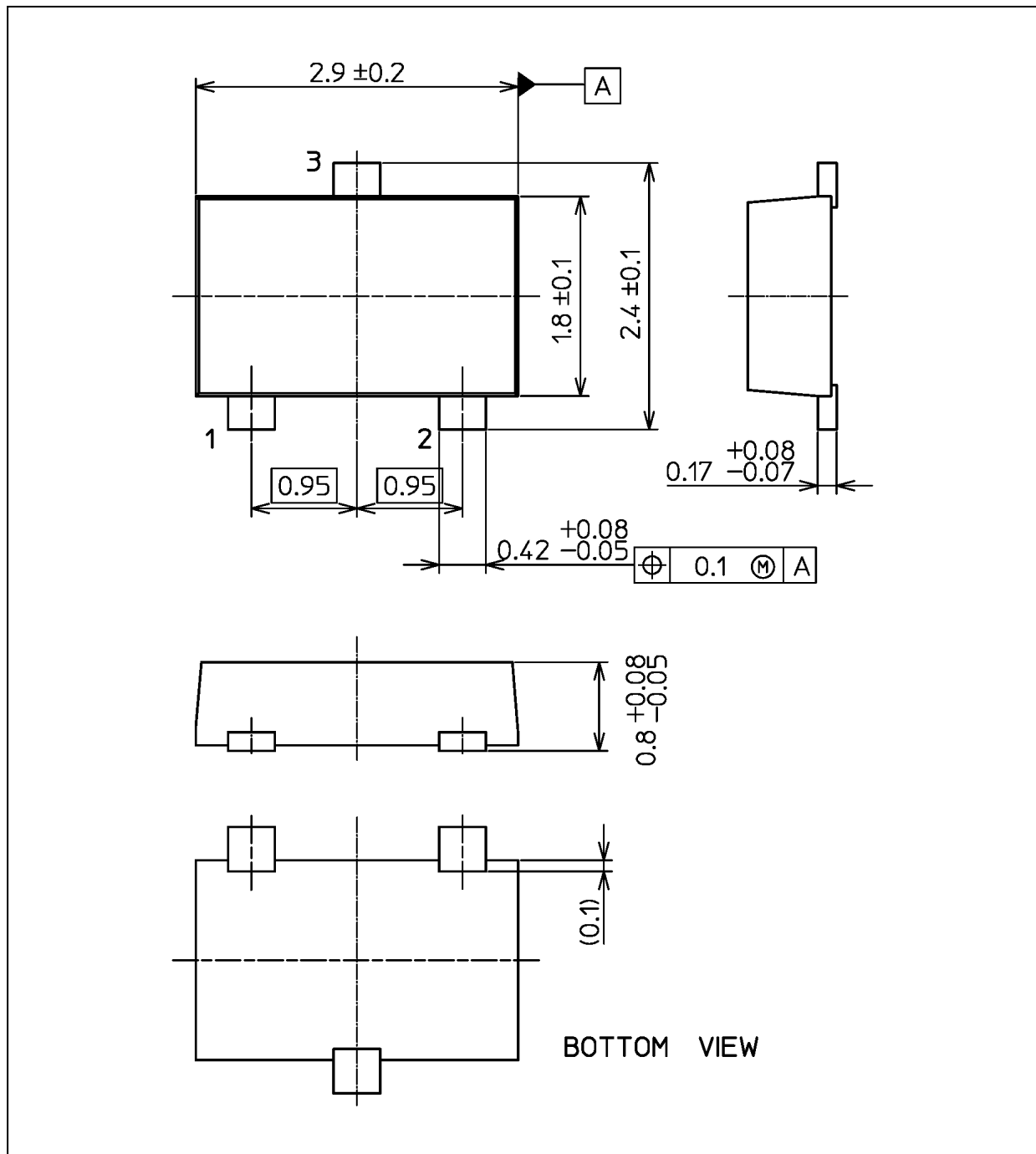


Fig. 8.15 Safe Operating Area
