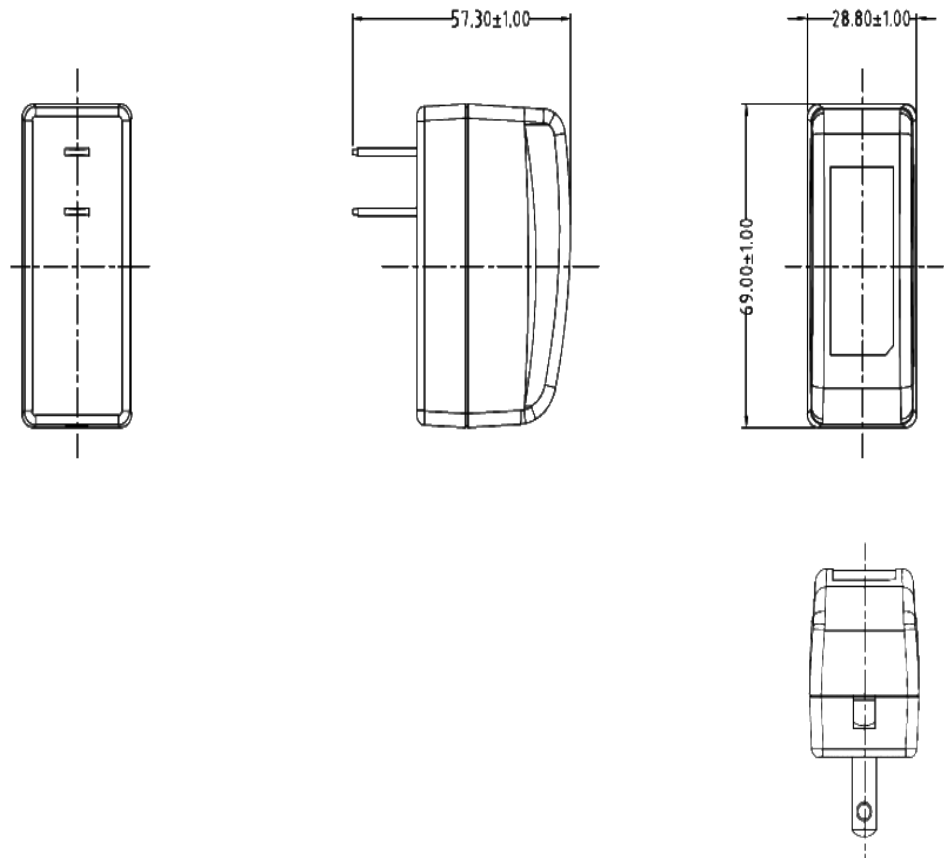

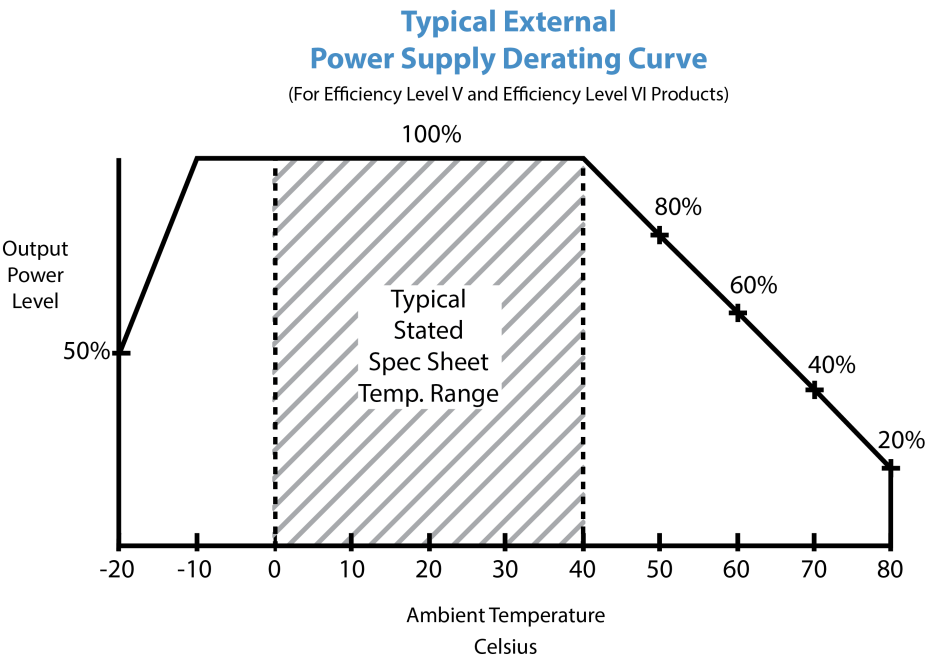

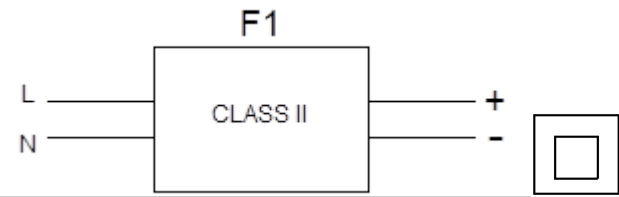
DERATING CURVE

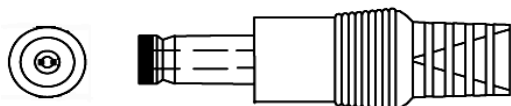

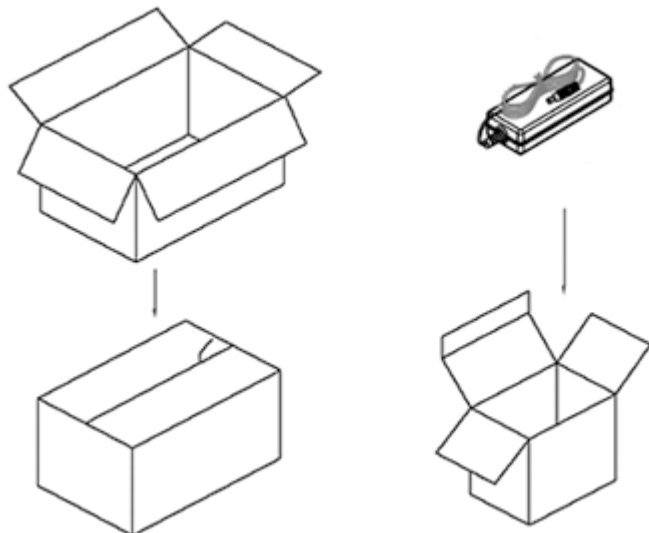
