




Fig. 6.3.1 Switching Time Test Circuit




Fig. 6.3.2 Input Waveform/Output Waveform






Fig. 8.1 ID - V_{DS}




Fig. 8.2 ID - V_{GS}




Fig. 8.3 R_{Ds(ON)} - V_{GS}




Fig. 8.4 R_{Ds(ON)} - ID




Fig. 8.5 R_{Ds(ON)} - T_a




Fig. 8.6 V_{th} - T_a




Fig. 8.7 I_{DR} - V_{DS}




Fig. 8.8 C - V_{DS}




Fig. 8.9 Dynamic Input Characteristics




Fig. 8.10 t - I_D




Fig. 8.11 r_{th} - t_w






Fig. 8.12 Safe Operating Area
