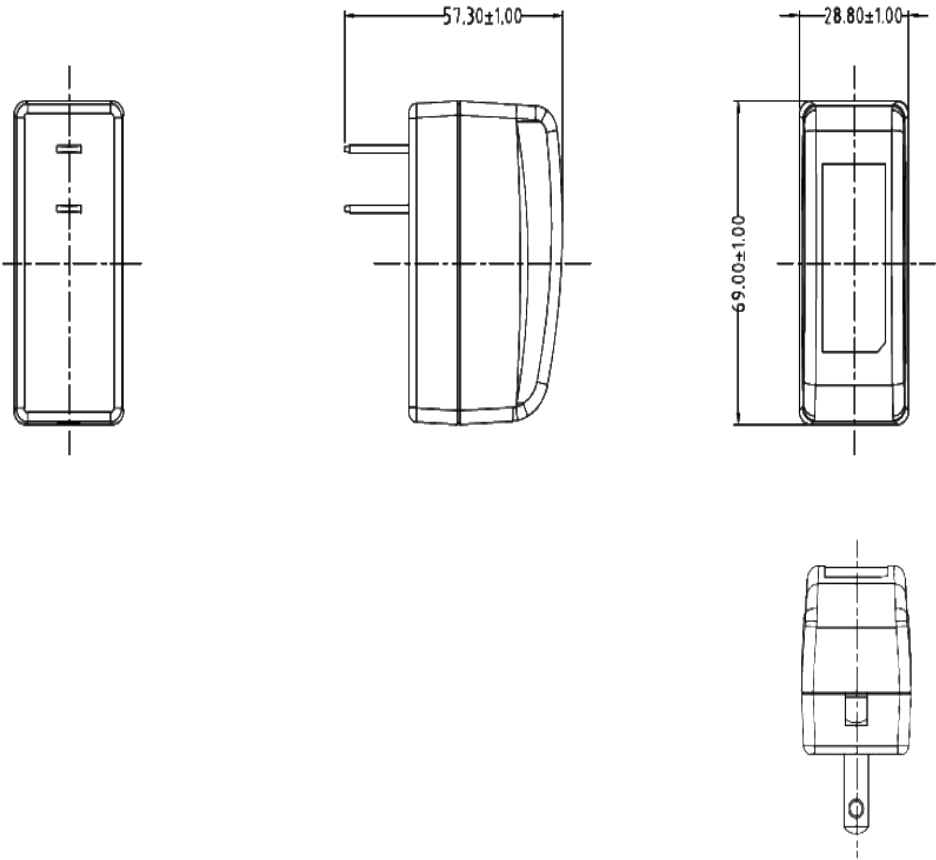

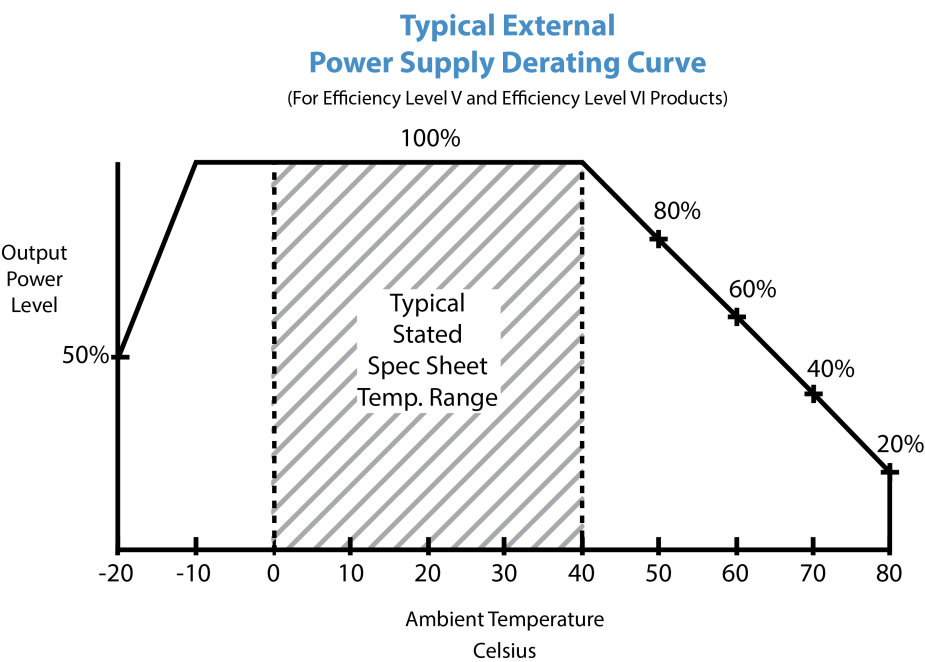

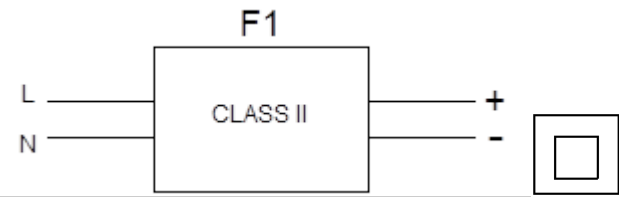
DERATING CURVE

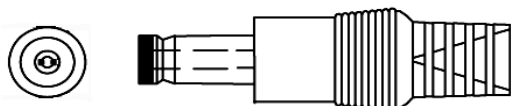

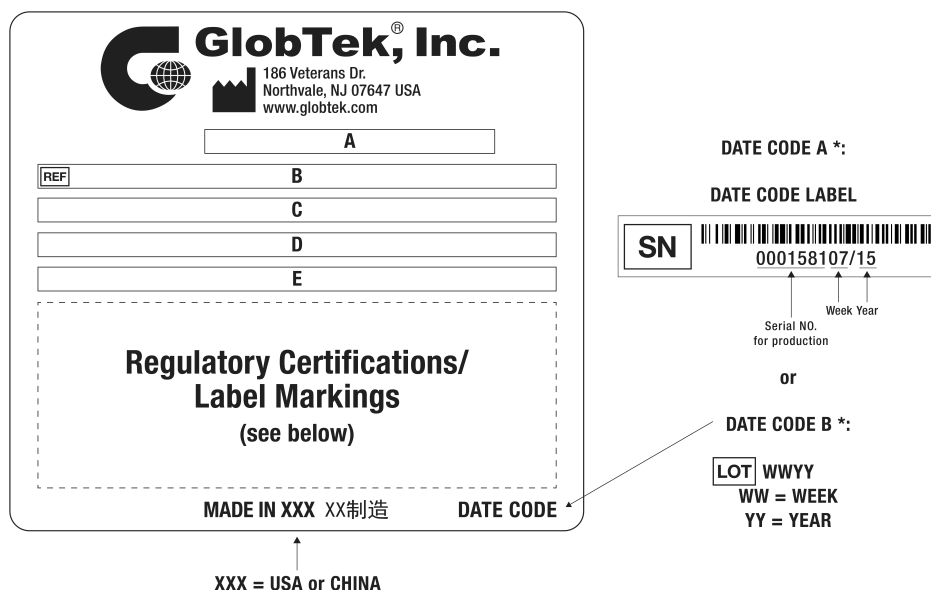

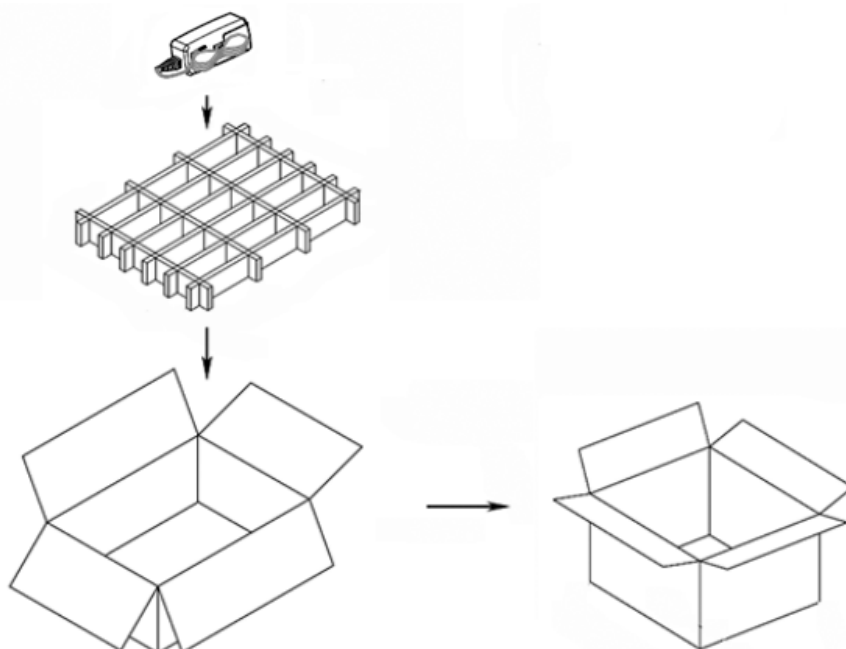
