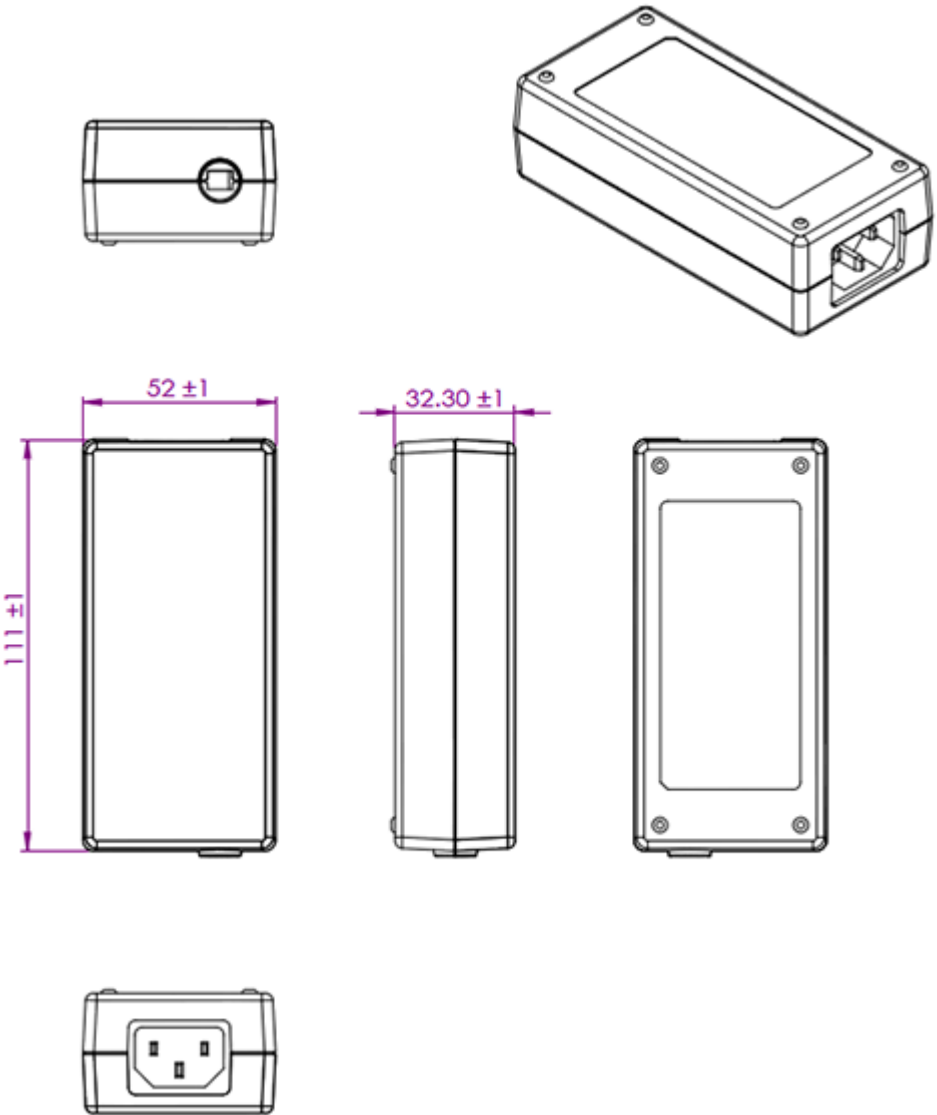

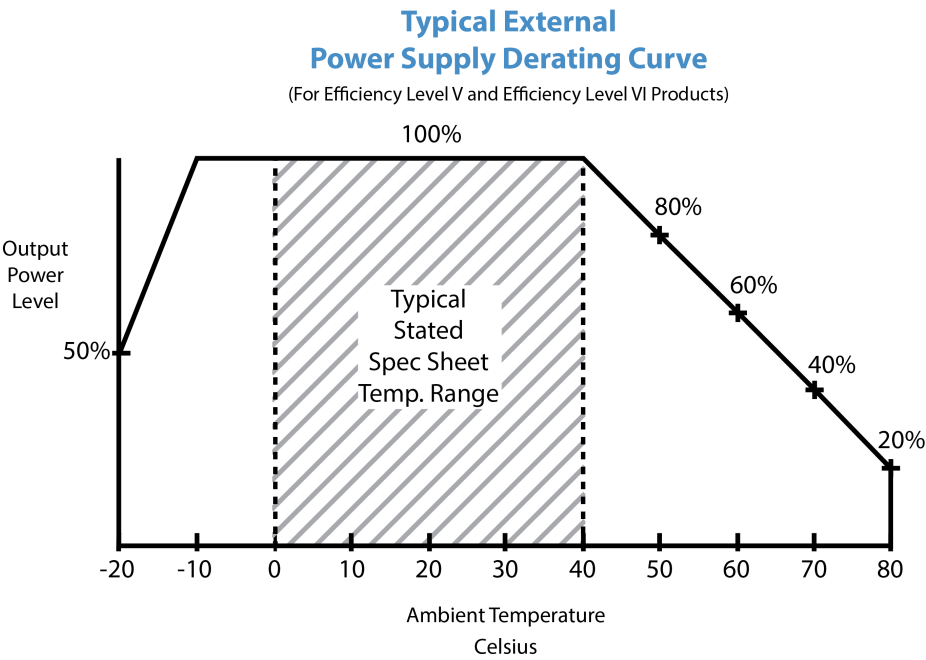

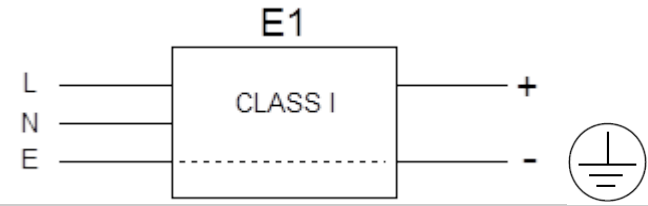
DERATING CURVE

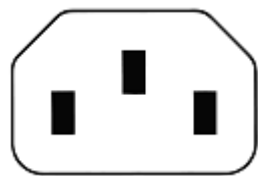
