



















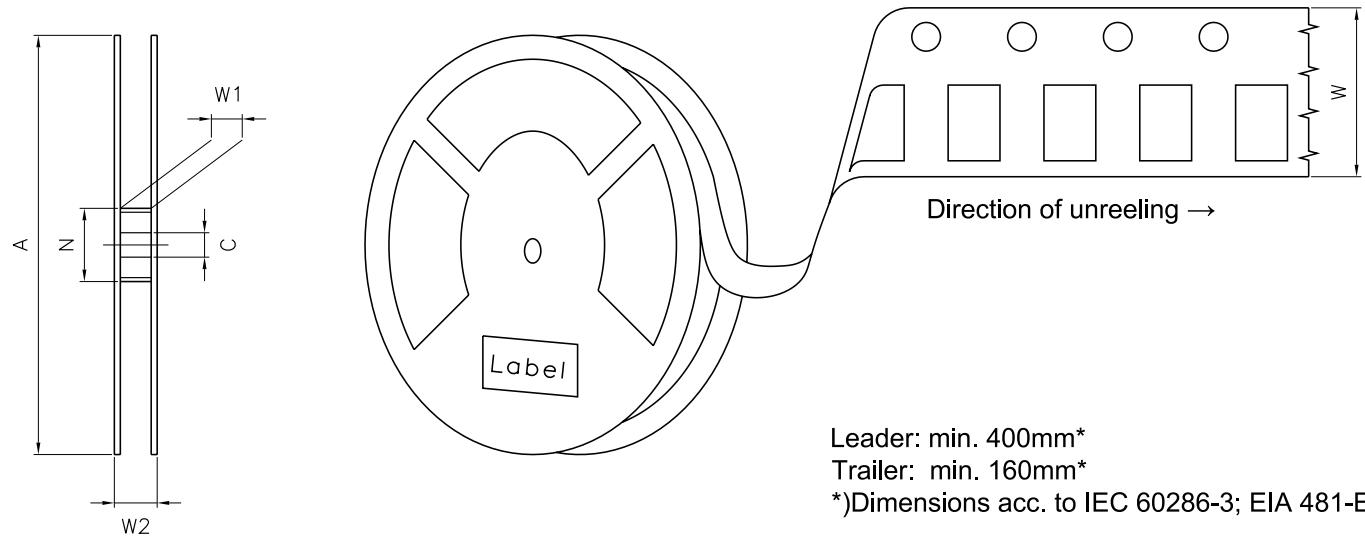





Glossary

- 3) **Peak Wavelength:** Wavelengths are tested at a current pulse duration of 10 ms and a tolerance of $\pm 3\text{ nm}$.
- 4) **Forward Voltage:** Forward voltages are tested at a current pulse duration of 1 ms and a tolerance of $\pm 0.1\text{ V}$.
- 5) **Thermal Resistance:** $R_{th\ max}$ is based on statistic values (6σ) used for Derating.
- 6) **Typical Values:** Due to the special conditions of the manufacturing processes of semiconductor devices, the typical data or calculated correlations of technical parameters can only reflect statistical figures.
